Cairo brought up the following points based on the UFC document: How is temporary structure defined? Lower limits of forces for wind and seismic is allowed, but what needs to be considered? Reevaluation of blanket approvals need to occur periodically. Are standard calculations acceptable and do these structures need to be periodically certified?
