- ICC Code Adoption – Greg gave “brief” summary of the process and what our role/efforts will be for the Group B Code Proposals in 2022.
- LARUCP Proposed Code Amendments (Greg) – Greg gave “brief” summary of this process and what our role/efforts will be. Assignments will be made at the November committee meeting. **Invite friends, colleagues, coworkers, etc. to take part in this effort.** We will be shooting for July 2022 release.
- Type V (WFPP) – The Wood Frame Prescriptive Provisions will be updated next year. We will be working on this later in 2022 (January 1, 2023 release).
- 3-D Printing Presentation Follow-up – A brief discussion occurred on the structural design of these structures. Since there are no current design standards for these structures, code alternates will need to be used (or HCD for prefabricated structures).
