ACI 318 will be split into 3 references → 319 (Precast structural concrete code), 320 (Post-tensioned structural concrete code), 318 will remain as general/scoping code. ACI 440 (Fiber-reinforced polymer reinforcement) is being developed and will be published soon. These standards will be available soon and may be adopted by the model Code in the coming future. Committee should continue to scan for these updated.
