### 6.0 OTHER ORGANIZATION REPORTS

6.1 CALBO Ron T. – spoke on Senate bill 1194 by Ben Allen, public restrooms and building standards, which does not require separate facilities for Men and Women it allows City to adopt. CALBO met and suggested language to use "may adopt". IPC already uses the language UPC turned it down. He stated if building or planning do not adopt then legislation is the way that requires jurisdictions to enforce. Assembly bill 2234 planning and zoning housing entitlement fees and permits requires all local agencies to have on webpage info on all post building permits, except populations under 75k, it passed the House/Senate/Committees, CALBO will notify the results, he stated negative impact is that you must have on city info online by January 01, 2024. Senate bill 897 for ADU/JADU. Expanding for planning on height/setback allowances/allowances for parking. The issue with building and fire officials is language states portion on property on ADU/JADU will not allow jurisdictions to assign R occupancies to them. Which means you cannot apply standards such as egress fire protection, electrical. They would remain U occupancies. The author is considering CALBO's input and will meet again and continue to fight against the bill. Check CALBO website for info. If attending ICC annual conference hearings, you must register to vote.

# PROGRAM - Field Inspection of Reinforcing Steel Presenters: Kevin Bott

Reinforcing steel is an essential component for the proper function of most modern structural concrete applications. This presentation reviews the multiple steps needed that verify and document the manufacturing, fabrication, and placement of the components in accordance with contract documents and building codes. Material testing reports and documentation provided by both the bar manufacturer and fabricator indicates the grade, type and location for each bar placement. Placing drawings generated by the bar fabricator and approved













by the structural engineer provide a road map for on-site installers to install the bars in the correct locations and manner. On-site inspections are conducted to confirm installation locations, field modifications and bar attachments meets accepted methodologies for handling and attachment as well as dimensional tolerances for placement perform as designed and specified.
