## TWISTED TINES HUNTING SERVICES OF NM , LLC

### CONTRACT FOR CLIENT USE OF OUTFITTER NUMBER

This CONTRACT is hereby made this \_\_\_\_\_ day of \_\_\_\_\_ of 2024, by and between Twisted Tines Hunting Services of NM, LLC., onward referred to as "TWISTED TINES" and \_\_\_\_\_, onward referred to as "CLIENT".

The use of the outfitter number will constitute as an agreement between Twisted Tines and the client. The agreement shall only be valid for one application year.

WITNESS that in consideration of their mutual covenants and agreements it is hereby mutually agreed as follows:

1. The Client may utilize Twisted Tines Hunting Services of NM LLC's outfitter number on their application, for any public land hunting license that is offered on the current Twisted Tines website. Or, by a separate agreement with Twisted Tines' owner, Miguel Gallegos.
2. Twisted Tines Hunting Services of NM LLC, agrees to sell the Client and the Client agrees to purchase, a hunt based on the successful drawing of a New Mexico hunting license, through the draw process of the New Mexico Game and Fish Department.
3. The price for the above indicated hunting trip will be the total amount indicated on the website of Twisted Tines Hunting Services of NM LLC, for the current application year or a previously agreed amount.
4. Upon a successful license draw, through the NMDGF, Twisted Tines and the Client will enter into a full contract, based on the desires of the Client as well as the hunt type selected. The Client agrees to pay 50% of the total amount of the hunting trip within 15 days of the successful draw. The remaining 50% is to be paid in full by cash, cashier's check, money order or other certified funds upon the client's arrival at the Twisted Tines campsite.
5. The Client acknowledges that if he/she cancels the hunt for any reason, there will be no refund of the deposit.

6. The Client also acknowledges that after utilizing Twisted Tines' outfitter number; under New Mexico law, his/her license will NOT be valid without being guided at the minimum of the first two (2) days of the hunt. The utilization of the outfitter number without being guided at least the first two days of the hunt will be in violation of New Mexico law and ANY ANIMAL HARVESTED WILL BE ILLEGAL.

Twisted Tines will assist the Client in the application process for the license.

After the application process is complete and has been submitted, please forward a copy of the application to Twisted Tines.
