2. Food Vendors are responsible for meeting all State Health Department requirements.
3. You cannot transfer your booth to another party without express permission from the event management (Wartrace Chamber).
1. All Exhibitors/Vendors must fit the Christmas/Holiday-theme.
4. Exhibitors must set up in area designated for vendors or get special approval from event management.
5. Exhibitors must furnish tables, chairs, and display equipment.
6. Exhibitors will be responsible for collection and reporting of Tennessee State Sales tax (9.75%).
7. Exhibitors must leave booth area in the same condition in which it was found.
8. Set-up time is Friday 5pm - 8pm and Saturday 6am - 9am.
9. Event will run from 10am - 5pm on Saturday.
