1. General booth fee is \$75.00 for one (1) 12'x12' and food/beverage truck/tent space is \$100. All booth fees are non-refundable unless the event is canceled. You may rent more than one booth. Please note that this is a rain or shine event.
2. Food vendors must have generator. Food/beverage vendors are responsible for meeting all State Health Department requirements and must provide proof of insurance for event along with this application.
3. Exhibitors/vendors cannot transfer booths to another party without express permission from the event management (Wartrace Chamber of Commerce).
4. All Exhibitors/Vendors must have hand-made, hand-crafted, homemade, or local products/produce, etc. NO DIRECT SALES VENDORS.
5. Exhibitors/vendors must park in area designated for vendors or get special approval from event management.
6. Exhibitors/vendors must furnish tents, tables, chairs, display equipment.
7. Exhibitors/vendors are responsible for collection/reporting of TN State Sales tax (9.75%).
8. Exhibitors must leave booth area in the same condition in which it was found. All Exhibitors/vendors must dispose of their own trash or may not be allowed to return.
9. Set-up time Friday at 5pm - 8pm. A few select booths will have setup on Saturday 6-8am.
10. Event will run from 9am - 5pm on Saturday. All must remain until end of event.
