- 1. The food/beverage truck fee is \$100.00. The Exhibitor vendor fee is \$50.00 for a 12'x12' space. Booth fees are non-refundable unless the event is canceled. You may rent more than one booth. Please note that this is a rain or shine event.
- 2. All food/beverage trucks MUST provide proof of insurance along with application. Food Vendors are responsible for meeting all State Health Department requirements.
- 3. Exhibitors/vendors cannot transfer booths to another party without express permission from the Event Management (Wartrace Chamber of Commerce).
- 4. Exhibitors/vendors must park in area designated for vendors or get special approval from Event Management.
- 5. Exhibitors/vendors must furnish tents, tables, chairs, lighting, and display equipment.
- 6. Exhibitors/vendors are responsible for collection/reporting of Tennessee State Sales tax (9.75%).
- 7. Exhibitors/vendors must leave booth area in the same condition in which it was found.
- 8. All trash and debris must be kept contained in bins or sturdy bags during show and piled neatly for Show Management to dispose of afterwards.
- 9. Set up time is Saturday from 8am to 11am.
- 10. All vendors must remain setup and open from 12pm 7pm on Saturday. Vendors may stay past 7pm if they wish until the end of the show at 10pm.
