It includes a fixed one-position handle for better balance, less carry fatigue and easy to use for right and left-handed users. Padded armrest and quick release arm strap come standard. Custom grip padding for handle and free POLICE or SHERIFF imprint.

Upgraded hardware ensures the ballistic performance of the shield is consistent throughout the surface. This shield and hardware passed and exceeded not only the RF2 threats, but also DEA and Special Threats like the M855 A1 and LPS projectiles. We think you still want .308 coverage so we test our shields against the testing to give you a true Level III++ / RF2 protection level. An extra pound gives you an extensive amount of extra protection.
