LICENCE DETAILS

Licence Type: RPB - Remote Applicator Business

DRONE AG SPRAY PTY LTD is hereby licensed under the Pesticides Act 1999 by the Environment Protection Authority. This licence authorises DRONE AG SPRAY PTY LTD to carry out the activities for the licence type listed above, in accordance with the conditions listed on this licence.

Responsibilities of licensee

Separate to the requirements of this licence, general obligations of licensees are set out in the *Pesticides Act 1999*, *Pesticides Regulation 2017* and other regulatory instruments (including but not limited to product labels and Pesticide Control Orders) in respect of prescribed pesticide work.

This Licence is issued with the conditions listed below. Failure to comply with any condition of the licence is an offence under *Pesticides Act 1999* that may result in a maximum court imposed penalty of \$120,000 for a corporation or \$60,000 for an individual.

Duration of licence

This licence is in force for up to five years from the date of issue, or until it is suspended, revoked or surrendered to the EPA.

Record keeping

The holder of the licence is required to keep records as set out in the *Pesticides Regulation 2017*. Such records must be made as soon as practicable after the use of the pesticide concerned and, in any event, no later than 48 hours after the pesticide is used.

Leakage or spills

AAB Licence and RAB Licence holders are required to notify the EPA of any incident where a pesticide leakage or spill has occurred as the result of a crash or forced landing of an aircraft operated under the authority of the licence. This notice must be given to the EPA as soon as practicable and in any event, no later than 48 hours after the incident occurs, as set out in the *Pesticides Regulation 2017* (cl.23).

All notifications for leakage or spills are required to be completed by contacting the NSW Environment Protection Authority's Environment Line on Ph 131 555

Remotely piloted aircraft - an unmanned aircraft, other than a balloon or kite, where the pilot flying is not on board the aircraft.

Visual line of sight - a RPA is being operated within the visual line of sight of the person operating the aircraft if the person can continually see, orient and navigate the aircraft to meet the person's separation and collision avoidance responsibilities, with or without corrective lenses, but without the use of binoculars, a telescope or other similar device.
