Dogs must have an ASCA registration number, LEP number, or tracking number.

Cancellation Policy: No refund requests will be issued after the closing date March 6, 2026.

No refunds will be issued for absent, disqualified, or excused dogs. No entry fee will be refunded if the show cannot be opened or completed for reasons of riots, civil disturbances, fire, Acts of God, or public emergency. Upon verification of a veterinarian or show committee member a refund will be given to bitches in season.

Awards: 1st-4th place and green qualifying or a "x" qualifying ribbon when applicable. Rosettes will be awarded to HIT, HIT Other Breed, HIT Junior, and High Combined.

Other Information:

This is an ASCA sanctioned event and will be governed by the rules of the Australian Shepherd Club of America.

The show will be held indoors on turf with a ring sized 50' x 50'. No crating in the building. Please be prepared to crate from your vehicle in the parking lot. No food and dog treats within 10 feet of the ring. Chairs will be allowed outside the ring on the asphalt.

Move-ups will be allowed between all trials.

Bitches in season will not be allowed to compete in these trials.

There will be an ASCA ASC of WA Agility trial in the adjacent ring.

Lunch and breaks will be taken at judge's discretion. There is no food on site.
