POLICIES: All Australian Shepherds must have an individual ASCA registration number to compete in rally and obedience.

ASC of WASHINGTON ASCA ALL BREED OBEDIENCE AND RALLY:

Classes: Master C, B & A, Excellent C, B & A, Advanced C, B & A, Novice C, B, & A

Classes: Utility B & A, Open CDX B & A, ODX B & A, Novice B, A & C, Sub-Novice, Beginner Novice A & B, Graduate Novice, Graduate Open

Entry limited to number of runs that can be held in 8 hours of judging spread over the 2 obedience trials. If we fill, entries will close. The high jump will have non-displaceable boards. Ring surface will be matted.

Novice B & A group exercises may be combined. Novice Group Exercises will be held after the Novice Individual Exercises.

POLICIES: Only regular classes are eligible for High Score Awards. Bitches in season will not be allowed to compete in Rally or Obedience. Upon verification of being in heat by a veterinarian or the Obedience/Rally Committee, the entry fee will be refunded if wished. All Breeds may compete; however, they are required to have an ASCA Tracking number. This number may be applied for at the show or online. QT tracker application: <https://asca.org/wp-content/uploads/2024/03/qtsvcapp.pdf> or the online QT application: <https://asca.org/qt-registration-application/> Owners/Handlers entering Novice Obedience/Rally who have titled a dog in any registry in Novice must enter Novice B. Any dog entering Novice or Open Obedience who has earned a CD or CDX in any registry must enter Novice B or Open B, as appropriate. Any dog entering Advanced or Excellent Rally who has earned a RA or RE or an equivalent title in any other registry, must enter Novice B, Advanced or Excellent Rally, as appropriate.

ASC of WA ENTRIES: Day of entries added on must pay day of entry fees. No refunds will be made if the show/trial cannot open due to riots, civil disturbances, acts of God, public emergencies or other events beyond the control of the ASC of WA.

Entries must be on an official ASCA form with the agreement signed on the back. Information must be complete, legible, and indicate the day and whether AM and/or PM show. No mail will be accepted without waiver of signature and will be returned if this is not done. Entry fees will be refunded

if an entry is pulled prior to the closing date of pre-entries, entry fees may be refunded if an owner presents the show committee, before the start of the show, a letter from a veterinarian stating the entrant should not participate due to health reasons. Returned checks from the bank will incur a \$20 fee. No entry shall be accepted from a dog disqualified from ASCA; or a person not in good standing with ASCA. EACH DOG'S ENTRIES FOR ASC OF WA EVENTS CAN BE ON THE SAME FORM, MULTIPLE COPIES ARE NOT NEEDED! Entries are to be sent to

From South:

I-5 North to exit 231 - Chuckanut Drive Hwy 11.

Crazy Round about Head North on Chuckanut or Highway 11.

(Take the 3rd turn out of first round about it will take you over the freeway. Then at the next round about get in Right lane and turn right on Highway 11 or Chuckanut drive.) Go about 5 miles turn right on Sunset. Go to stop sign and turn right on Worline.

Our farm is the first dairy on the right.

The sheep are next to the brown pole building (pictured above)- park and wait at the building. Please do not park at house.

From North:

I-5 to Exit 236 - Bow - Hill Exit.

Turn right (west) at stop sign.

Go about a mile or two and turn left on Ershig.

Go down the hill and over railroad tracks. Turn right on Worline. Pass the second dairy on the left. Brown building (pictured above) on the left park and wait at the building. Please do not park at house.

From Anacortes or Whidbey Island:

Hiway 20 - Turn Left (east) on Farm to Market Road - it is the road past the Farm House and to LaConnor.

Follow that road for a while you will be in treed area and then you will drop down in to the Skagit Flat, about another 1 mile. Turn Right on Sunset, you have gone to far if you get to Edison.

Follow Sunset threw a stop sign that is Chuckanut Drive go straight.

When the road comes to a T - turn right onto Worline.

3rd place on the right big brown pole building (pictured above)- park and wait at the building. Please do not park at the house.
