- Exit WA-16 West
- WA-16 merges into WA-3N
- Exit 45B to merge onto WA-303 S/NE Waaga Way toward East Bremerton
- Take the Central Valley Exit
- Left onto Central Valley Rd
- Right onto Fairgrounds Blvd
- Right onto Nels Nelson
- Entrance will be on Left side – Look for the MudPACK Agility Sign

### From WA 3 South

- Exit 45 – WA-303 toward Silverdale/East Bremerton
- Use Left two lanes to turn Left onto WA-303 S/NE Waaga Way toward East Bremerton
- Take the Central Valley Exit
- Left onto Central Valley Rd
- Right onto Fairgrounds Blvd
- Right onto Nels Nelson
- Entrance will be on Left side – Look for the MudPACK Agility Sign

No entry shall be accepted from a dog or handler disqualified from the ASCA Rally program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA.

Bitches in season will not be allowed to compete. Upon verification of being in heat by a veterinarian or the Rally Committee, the entry fee will be refunded if wished. Request for entry refunds will be honored if requested prior to close of pre-entries.
