<u>POLICIES:</u> An official waiting list will be maintained. A draw for run order will be made prior to the trial. Entries can be withdrawn before the pre-entry date closes. If an owner pulls an entry after the close of entries no refund will be made unless that space can be filled from the waiting list, except for injured dogs (see entry paragraph above). Substitution of a dog owned or co-owned by the same owner is allowed. NOTE: Refunds will take time. Bitches in season shall run in order. - Take Hwy 16 past Gig Harbor. **Exit** at sign for Hwy 302W (Purdy/Shelton).
- Follow exit road into Purdy to the traffic light
- Turn left at signal following sign for Hwy 302W (Shelton/Key Center) -- you will cross the Wauna Bridge.

General Rules:

- 20 minutes: 10 and 3 minute warning
- All tasks must be completed before moving on
- All gates may be open/closed at the Handler's discretion (unless specified); however time will not end until all gates have been restored to their original/starting position.
- Tie breaker in the following order: Chute work, Sort, Time

Starting Set Up:

All gates are closed

Five head of cattle in the Stockyard, sets of 5 cattle in the holding pens.

- **1. Pen 1 5 points:** Move cattle to P1. Starts when dog and handler enter pen. Ends with stock in P1
- 2. Chute -20 points: Put cattle into the Alleyway Chute (4 x 30). Release cattle Starts when in P1. Ends when the cattle exit Alleyway chute
- 3. Pen 2 5 points: Take 5 head in to P2. Begins when cattle exit chute. Ends when cattle are in P2.
- **4. Pen 3 5 points:** Take 5 head from P2 into Arena A. Starts when P2 gate is opened. Ends when cattle are in Arena A.
- **5. Gather 20 points:** Dog is set at designated cone 150 feet from stock to gather Stock and bring them to the upper left hand corner of the arena., going clock wise around the designated cone. Starts when dog is sent on gather. Ends when cattle are at the corner.

ADVANCED: Handler and dog are at designated cone.

OPEN: Dog is at designated cone. Handler may be ½ way to stock to send dog.

6.. Task 1: Hold – 20 points: Dog holds stock in the upper left hand corner of the arena until handler opens P5 gate.

ADVANCED: dog stays with stock until handler gets to P5 gate and designated cone.

OPEN: dog stays with stock until handler is ½ way to P5 gate and designated cone.

- 7. Sort 25 points: Sort 3 marked cows into P5. Then add remaining animals in to P5. Starts when cattle are at the upper left hand corner of the arena. Ends when all animals are in P5 and the gate is closed.
- **8.** Task 2 20 points: Take cattle from P5 to Back Alley to gate of P2. Starts when cattle exit P5. Ends at gate of P2.


ADVANCED: Handler stands at gate of P5 until cattle reach gate to P2

OPEN: Handler can move anywhere.

- **9. Pen 4 5 points:** Pen cattle in P2. Starts when gate to P2 is opened. Ends when cattle are in P2 and the gate is shut.
- **10. Pen 5 5 points:** Take stock from P2 to narrow alleyway. Starts when P2 gate is opened. Ends when cattle are in the narrow alleyway.

ASC of Washington August 2022 Farm Trial Mixed (Ducks and Sheep)

General Rules:

- 25 minutes: 10 and 3 minute warning
- All tasks must be completed before moving on
- All gates may be open/closed at the Handler's discretion (unless specified); however, time will not end until all gates have been restored to their original/starting position.
- Tie Breaker, in the following order: Gather, Sort, Time

Starting Set Up:

All gates are closed

- 5 ducks in Pen B
- 5 Sheep in Pen C, sets of 5 sheep in holding pens.
- **1. Pen 1 5 points:** Start at the Duck Arena: Take Ducks out of Pen B. Starts when gate is opened and ends when the ducks are in the Duck Arena and gate is closed.
- **2. Gather 20 points:** Call dog off and move 75 feet to handler's cone to send dog. Starts when dog is called. Ends when ducks are gathered at the cone.

ADVANCED: dog and handler send from the post. **OPEN:** Dog starts from post. Handler can move ½ way to ducks

- **3.** Chute 20 points: After gather, move ducks through chute on fence (2 x 8) and then open gate. Starts when ducks are gathered. Ends when ducks exit chute.
- **4. Pen 2 5 points:** Take ducks to Pen A and pen them. Starts when ducks exit chute and ends when ducks are in Pen A.
- **5. Pen 3 5 points:** Take ducks out of Pen A and hold them at Pen A while handler closes the gate. Return ducks to Pen B. Place dog on leash, exit Duck Arena. Starts when gate opens. Ends when gate to Pen B closes. Move to Sheep Bottom Field. Unleash dog after entering Sheep Bottom Field at 100 x 100 arena gate.
- 6. Pen 4 5 points: Take Sheep out of Pen C and into 100×100 pen Starts when pen is opened. Ends when sheep are in 100×100 pen.
- 7. Sort 25 points: Sort 3 marked sheep into the 180×140 arena. Then put the remaining 2 sheep in with the 3 sheep. Starts when sheep are in the 100×100 pen. Ends when all sheep are in the 180×140 arena.
- 8: Task 1: Ribbon pull 20 points: Remove ribbons from the sheep. Starts when the sheep are combined in the 180×140 arena. Ends when the ribbons are removed.


ADVANCED: Remove ribbons from 3 sheep OPEN: Remove ribbons from 2 sheep

9. Task 1-20 points: Move sheep to the gate of the round pen: Allow Sheep to go thru gate as prescribed. Starts once the ribbon pull is finished. Ends when sheep are in the round pen.

ADVANCED: all sheep enter 1 at a time. **OPEN:** at least 3 sheep enter 1 at a time

10. Pen -5 points: Hold sheep against the fence while opening the gate to the exhaust pen. Starts when the sheep enter the round pen and ends when the sheep are in the exhaust pen


