Non-regular to be divided by sex: Puppies: 2-4 month, 4-6 month; 7-9 Veterans, 10+ veterans

Altered& Intact to be divided by sex: 6-9 months, 9-12 months, 12-15 months, 15-18 months Novice, American Bred, Bred by Exhibitor, Open Blue Merle, Open Red Merle, Open Black, Open Red, Best of Breed

Junior Regular Handling Classes: Novice & Open, to be divided by ages: 8-12 years & 13-17 years

POLICIES: All Australian Shepherds **must** have an individual ASCA registration number to compete, except non-regular puppies, which **must be eligible** for ASCA registration.

POLICIES: Juniors may compete with any breed; however for ASCA points in the merit programs, the dog must be an Australian Shepherd, must meet ASCA Junior ownership requirements and be an ASCA Junior Member.

ASC of WASHINGTON ASCA ALL BREED OBEDIENCE AND RALLY:

Classes: Master C, B & A, Excellent C, B & A, Advanced C, B & A, Novice C, B, & A

Classes: Utility B & A, Open CDX B & A, ODX B & A, Novice B, A & C, Sub-Novice, Beginner Novice A & B

Entry limited to number of runs that can be held in 8 hours of judging spread over the 2 obedience trials. If by some miracle, we fill, entries will close.

Novice B & A group exercises may be combined. Group exercises will be held after the individual exercises.

POLICIES: Only regular classes are eligible for High Score Awards. Bitches in season will not be allowed to compete in Rally. Bitches in season can compete for legs and QS only in the PM obedience trial. They must wear pants and be crated 50 feet from the ring. Upon verification of being in heat by a veterinarian or the Obedience/Rally Committee, the entry fee will be refunded if wished. All Breeds may compete; however, they are required to have an ASCA Tracking number. This number may be applied for at the show. Owners/Handlers entering Novice Obedience/Rally who have titled a dog in any registry in Novice must enter Novice B. Any dog entering Novice or Open Obedience who has earned a CD or CDX in any registry must enter Novice B or Open B, as appropriate. Any dog entering Advanced or Excellent Rally who has earned a RA or RE or an equivalent title in any other registry, must enter Novice B, Advanced or Excellent Rally, as appropriate.

ASC of WA ENTRIES: Day of entries added on must pay day of entry fees. No refunds will be made if the show/trial cannot open due to riots, civil disturbances, acts of God, public emergencies or other events beyond the control of the ASC of WA. Entries must be on an official ASCA form with the agreement signed on the back. Information must be complete, legible, and indicate the day and whether AM and/or PM show. No mail will be accepted without waiver of signature and will be returned if this is not done. Entry fees will be refunded if an entry is pulled prior to the closing date of pre-entries. Entry fees may be refunded if an owner presents the show committee, before the start of the show, a letter from a veterinarian stating the entrant should not participate due to health reasons. Returned checks from the bank will incur a \$20 fee. No entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA. **EACH DOG'S ENTRIES FOR ASC OF WA EVENTS CAN BE ON THE SAME FORM, MULTIPLE COPIES ARE NOT NEEDED!** Entries for all shows, except OASC, are to be sent to **Michelle Berryessa, PO Box 519, Roy, WA 98580. Funds must be in US dollars.**

DIRECTIONS to Rainier Sportsman Club. From the south, take exit 88A. Stay on this road going thru Tenino and on to Rainier. As you are going thru Rainier, take a right on Alaska. Go straight into the Sportsman Club grounds. We will be down on the infield by the car racetrack. From the North, take the Mounts Rd Exit 116, go left on Old Nisqually Rd. Go about 3.8 miles and take a left on Reservation Road. Go to the end and take a left on Hwy 510 (this is a roundabout – take the 2nd road), at the next roundabout, take the 2nd exit,

staying on Hwy 510. At the 3rd roundabout take the 1st exit, staying on Hwy 510. Go into Yelm and take a right on First St S, which is also Hwy 507. Continue into Rainier and take a left on Alaska, then go straight into the Rainier Sportsman Club grounds.

CAMPING: This facility is dry camping only. Fee/night for tents or trailers: \$10 with no hook up, Sites first come, first served. Grooming setup at the conformation/obedience area will NOT be allowed prior to the setup of the rings. Any setups or marked spaces will be removed until that time. Grounds will be available from 7am to 7 pm

SET UP AND TAKE DOWN: We will start setup of the rings at 5pm Friday and take down after the show/trials are over. Please lend a hand.
