Please read the following terms and conditions prior to accepting them and prior to creating an account. Creation of an account is not permitted without checking a box that signifies that you agree to these terms and conditions. Therefore, if an Account is created, You are agreeing to having read and understood the terms and conditions and to abide by them.

## **Interpretation and Definitions**

### Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

#### **Definitions**

For the purposes of these Terms and Conditions:

- Application means the software program provided by the Company downloaded by You on any electronic device, named Saheli.
- Application Store means the digital distribution service operated and developed by Apple Inc. (Apple App Store) or Google Inc. (Google Play Store) in which the Application has been downloaded.
- Affiliate means an entity that controls, is controlled by or is under common control
  with a party, where "control" means ownership of 50% or more of the shares, equity
  interest or other securities entitled to vote for election of directors or other
  managing authority.
- Account means a unique account created for You to access our Service or parts of our Service.
- Country refers to: United States
- Company (referred to as either "the Company", "We", "Us" or "Our" in this
  Agreement) refers to Saheli LLC, 651 N Broad St, Suite 201, Middletown, Delaware
  , 19709.
- Content refers to content such as text, images, or other information that can be posted, uploaded, linked to, entered, or otherwise made available by You, regardless of the form of that content.

- **Device** means any device that can access the Service such as a computer, a cellphone or a digital tablet.
- **Feedback** means feedback, innovations or suggestions sent by You regarding the attributes, performance or features of our Service.

- Issues with the Seller of the Goods

We also reserve the right to refuse or cancel Your Order if fraud or an unauthorized or illegal transaction is suspected.

**Order cancellation,** takes place before the product has been shipped or received by the buyer. It involves nullifying the transaction entirely. In this scenario, no physical return of goods is necessary because the purchase hasn't been completed yet.

#### **Your Order Cancellation Rights**

A buyer shall not have the right to cancel an order. Any Goods you purchase can only be **returned** in accordance with these Terms and Conditions and Our Returns Policy. Any Goods you purchase in a transaction cannot be cancelled after it is placed. A cancellation is when an Order is stopped and halted before it has reached the buyer. #### **RETURNS POLICY**

Your right to return an Order only applies to Goods that are returned in the same condition as You received them. Goods that are damaged or not in the same condition as You received them or which are worn simply beyond opening the original packaging will not be refunded. Your right to return an Order is dissolved after the 48 hours after which the package containing the Goods is delivered to your address provided. A package or Goods will be considered delivered once the USPS tracking label provided by the seller of the Goods deems them delivered.

We will reimburse You no later than 14 days from the day on which the seller receives the returned Goods. We will use the same means of payment as You used for the Order, and You will not incur any fees for such reimbursement except the shipping costs for returning the Goods. The shipping costs for returning any item will be Your responsibility, as the buyer.

### Returns are only accepted on the basis of:

- One or more of the item(s) contained in the purchase deviate **significantly** from the listing's photos and description.
- One or more of the item(s) contained in the purchase are damaged.

Saheli reserves the right to accept returns upon its own discretions and reserves the right to deny returns if reason for return seems invalid. Invalid reasons for returns include but are not limited to:

- A change of mind or heart regarding the need or want of the Goods.
- Slight and mild deviation in sizing. Buyer, by accepting this agreement, is acknowledging that sizing in Goods can vary slightly.
- Your preference or perception of the item differing from Your initial expectations formed through online viewing. We encourage customers to carefully review product descriptions, images, and specifications provided on our platform prior to making a purchase decision.

#### Order Cancellation by Seller:

Upon listing any Goods on the platform, a seller agrees to ship any Goods sold in the allotted time frame of 72 hours from the time of sale. An Order will be cancelled by the Company if the Seller does not ship the Goods in the allotted time frame of 72 hours. If the Company is forced to cancel the Order due to this violation, a seller will be charged a cancellation fee of \$20 USD plus other processing fees that Saheli may incur. You as a seller of any Goods agree to this cancellation fee as part of these Terms of Service.
