

DOES YOUNG WOMEN CAMP CODE OF CONDUCT

I am a voluntary participant in this Dayton Ohio East Stake Young Women Camp and I will accept full responsibility for my actions under all conditions. I also agree to aid other members of camp in behaving responsibly.

I will abide by and maintain the standards of the Church of Jesus Christ of Latter-Day Saints as outlined in the "For the Strength of Youth" pamphlet and as encompassed in the Gospel of Jesus Christ in my language and behavior while at Young Women Camp. This means high standards of behavior, honor, and integrity.

I will respect the rights of others and treat them with consideration at all times. This includes complying with leaders' instructions, remaining in the campsite or presence of my leaders as instructed, and not disturbing the personal belongings of all others. I will not do anything harmful to others physically, spiritually, or emotionally including bullying or pulling pranks on others.

I will respect the property and grounds of the campsite and transport vehicles and will not deface or harm them in any way.

I will not leave the campsite or remove myself from the supervision of adults during any Young Women Camp activity without prior permission.

Any medication (prescribed or over-the-counter) that I bring to camp must be reported to the camp Nurse. The camp nurse will be responsible for administering the medication to me as prescribed. I will not have any medication that is not reported and will not take any medication that is not administered by the camp Nurse.

I understand that my Young Women leaders value my physical, mental and spiritual safety, along with the safety of others. As such, I understand the following behaviors will result in my parents being contacted to pick me up from camp immediately:

- Threat or attempt of suicide
- Threaten or act of Self-Harm (including cutting)
- Serious intentional mis-use of Medication (reported or non-reported medication)
- Participating in or encouraging immoral behavior of any kind, which includes any sexual misconduct, breaking the law of chastity, inappropriate touching, kissing or viewing pornography in any form.
- Breaking the word or wisdom, including possessing illegal Drugs, Vaping, Smoking, Alcohol
- Stealing, Theft or Vandalism of any kind
- Use of weapons (scissors, knives, firearms, etc) of any kind to threaten themselves or others. Any objects that could be considered a weapon should only be brought to camp with explicit parental approval.

I have read the Young Women Camp Policies Sheet and agree to abide by them.

I acknowledge and agree to live by this code of conduct as a participant in the Dayton Ohio East Stake Young Women Camp. I understand that failure to do so may result in being sent home early.
