## Nevada LAWS

### UAPPEAL

## DANGEROUS WILD ANIMAL - DIRECT CONTACT

Bans direct public contact (physical contact or close proximity where physical contact is possible with public including photo ops without permanent barriers) with dangerous wild animals.

#### EXEMPT:

- owner
- employee or other person conducting duties
- veterinarian providing treatment
- law enforcement or animal control
- Department and agents or employees

### LIST:

- Bears: American black (captive bred), Asiatic black, brown, giant panda, polar, sloth, spectacled (& hybrids) & sun bear
- Canines: gray wolf; red wolf (captive bred)
- Elephants (Elephas, Loxodonta)
- Felines: cheetah, clouded leopard, jaguar, leopard, lion, mountain lion (captive bred), snow leopard, tiger, hybrids
- Hyena, aardwolf
- Nonhuman primate

### **SEIZURE AND PENALTY:**

- Law enforcement or animal control may seize for probably cause of violation (may be kept on premises until location found)
- Allows court to order forfeiture if found guilty
- Forfeited animals may be return if not in violation, owner corrects violations, return doesn't cause
  public health or safety risk, not treated cruelly and in compliance, but may NOT be returned if
  possession determined to be prohibited and must be euthanized
- Penalty is up to \$20,000 civil penalty.

## WILDLIFE TYPES

Alternative livestock – captive-bred fallow deer and reindeer for by-products or breeding stock

- Migratory game birds all game birds in MBTA including ducks, geese brants and swans (Anatidae); wild doves and pigeons (Columbidae); sandhill cranes (Gruidae), rails, coots and gallinules (Rallidae) and woodcocks and snipes (Scolopacidae)
- Upland game birds blue, ruffed, sage and sharp-tailed grouse; chukar, gray and snow partridge; ring-necked and white-wing pheasant, Northern bobwhite, California, Gambel's, mountain and scaled quail; wild turkey; American crow
- Protected birds all MBTA except migratory game birds; endangered, threatened and sensitive species
- Unprotected birds house sparrow, starling, unlisted birds

### Fish

- Coldwater Game fish Bonneville, Lahontan and Snake River cutthroat trout; Atlantic salmon; brook, brown, bull, lake, rainbow, and redband trout; mountain whitefish
- Warmwater Game fish black and brown bullhead; channel and white catfish; striped, white, largemouth black, smallmouth black, and spotted bass; black and white crappie; Sacramento and yellow perch; bluegill, green, and redear sunfish; walleye
- Protected fish endangered, threatened and sensitive species; Alvord Tui, Fish Creek Springs
  Tui and Sheldon Tui chub; Oasis Valley speckled dace; virgin spinedace; Wall Canyon, Warner
  and White River Desert suckers; Moorman White River and Preston White River springfish
- Unprotected fish all unlisted fish

# WILDLIFE AND GAME FISH (TRANSPORT, SALE AND PURCHASE)

BANS sale, purchase and trade of wildlife and game fish unless specifically allowed by law.

- EXEMPT:
  - products
  - alternative livestock
  - dead game fish

BANS taking game fish away from body of water taken in.

(NRS 501.379, 501.381; NAC 503.115)

## LIVE WILDLIFE (POSSESSION, EXPORT AND IMPORT)

PERMIT (Commercial or Noncommercial Live Wildlife License) required to possess any wildlife.

• EXEMPT: alternative livestock

PERMIT (Importation Permit) required to import wildlife.

- EXEMPT: species specifically allowed to be imported on permit
- Need certificate of health for birds, fish and mammals and fish and ungulates must be authorized on license
- Ungulates need importation permit from Division of Wildlife and Agriculture, health certificate and certificate of examination, and quarantined for 30 days after

PERMIT (Exportation Permit) required to export wildlife.

- EXEMPT:
  - o species specifically allowed to be exported on permit
  - o acquisition from person exempt from permit with receipt
  - o birds and fish and unprotected reptiles and amphibians exempt from permits generally

### EXEMPT from commercial and noncommercial, importation and exportation permit:

- Species in NAC 503.140
- These birds and fish on private property or private lake or pond: California, Gambel's, scaled and mountain quail; Chukar and Hungarian partridge; Ring-necked and white-winged pheasant; Bobwhite quail; Rainbow, brown, cutthroat, brook trout; Largemouth and smallmouth bass; Bluegill and redear sunfish; Channel catfish; Black bullhead; Crappie
  - BANS sale, release without permission, hunting except training permit, capture from wild, import without importation permit unless NPIP, transport without invoice and display of birds and fish exempted
  - May allow other endemic fish
- Unprotected reptiles and amphibians for noncommercial or personal use up to limits listed
  - o BANS sale and barter, release if removed from site, and public display
- Under a scientific and educational license display or exhibit if no fee charged
- Under a USDA Exhibitor license less than 90 days

### **REQUIREMENTS:**

- COMMERCIAL LIMITED TO: Chukar and Hungarian partridge; California, Gambel's, scaled, mountain and bobwhite quail; ring-necked and white-winged pheasant; indigenous reptiles and amphibians
  - May allow fish, crustaceans and mollusks
- MAY allow other species for both permits
- LEGAL SOURCES: breeder or dealer, collection in another state, department (BANS sale and barter)

- Commercial BANS release and hunting (except upland game birds for competitive field trial or training dogs or falcons or commercial or private shooting preserve)
- Noncommercial BANS sale, trade and barter, public displays, hunting (except upland game birds for competitive field trial or training dogs), and release without authorization
- Ungulates need ear tags or permanent mark, AND bobcats, mountain lions and black bears need tattoo
  in left ear need facility to do so
- Meet caging rules in 504.476 or 504.478 (new permits after 2/28/94)
- BANS capturing wildlife in state to stock commercial or noncommercial wildlife facility

## PROTECTED WILDLIFE (TAKE AND POSSESS)

PERMIT required to hunt or take or possess protected wildlife.

- EXEMPT:
  - Desert tortoise held in captivity on 8/4/89 or 1 tortoise acquired through USFWs adoption program
  - Wildlife lawfully killed and imported from another state under that state's authorization
  - Taking protected vector or protected venomous reptile in residence, school or building open to public OR if necessary to protect life of person in imminent danger

(NAC 503.093)

## OTHER WILDLIFE PERMITS

- Shooting Preserve License (take upland game birds on preserve) Commercial or Private
- Live Bait Dealer Permit (sell and transport fish and aquatic life for commercial purposes)
  - LEGAL SPECIES: as allowed in Western and Southern regions: Lahontan redside, red shiner, Tui chub, Speckled dace, Mosquitofish, Carp, Goldfish, Golden shiner, Fathead minnow, Threadfin shad, Mountain sucker, Tahoe sucker, Longjaw mudsucker, Waterdogs, Piute Sculpin
  - Allows import of bait (salamander must come from installments or areas in bordering states)
     with invoice and notice to department 3 days prior

- Competitive Field Trials Permit (competitive field trials for hunting dogs or falconry)

- Falconry License
- Permit to Take a Raptor for Falconry (take raptor from wild)
- Raptor Propagation Permit (propagate and sell raptors)
- Scientific Collection/Possession/Import/Export/Banding License (take, kill, possess and band wildlife for scientific or educational purposes)
  - o MBTA and USFWS endangered and threatened species need copy of federal permit
- Special Purpose Permit (handle, move or temporarily possess protected wildlife to reduce risk of harm due to allowed activity)
  - MBTA and USFWS endangered and threatened species need copy of federal permit
- Commercial Collection of Unprotected Wildlife Permit (commercially take unprotected wildlife)
  - Fish/Aquatic Bait
  - Unprotected Fish
  - Nuisance Wildlife
- Permit to Release Live Wildlife (release wildlife into state)
  - o Required when other permits do not authorize it
- Import Eligibility Permit
- Rehabilitation Permit
  - EXCLUDES: foxes, skunks, raccoons, coyotes, rats, mice, ground squirrels, and bats; species in NAC 503.110; species prohibited by county or city where facility located
  - Unreleaseable may be sent to AZA zoo
  - o Must release raptors within 180 days and other wildlife within 90 days unless extended
- Triploid Grass Carp Stocking Permit (stock certified triploid grass carp in closed aquatic system)

### **REQUIREMENTS:**

- Released or escaped wildlife must be immediately reported and department can capture or destroy such wildlife
- · BANS releasing mammal for hunting

# **BULLFROGS OR CRAYFISH (GAME)**

BANS commercial take of crayfish.

• EXEMPT: permit for Lake Tahoe with sales limited to food wholesaler or restaurant for consumption

NO PERMIT NEEDED to take bullfrogs or crayfish by methods other than hook and line.

• PERMIT (Fishing License) required to take bullfrogs or crayfish by hook and line.

LEGAL METHODS: spear, bow and arrow, hook and line along with hands or gigs for bullfrogs

ILLEGAL METHODS: firearm or airgun (bullfrogs)

## UNPROTECTED REPTILES AND AMPHIBIANS

BANS commercial take of unprotected reptiles and amphibians since 2017.

Allows noncommercial take of unprotected reptiles and amphibians. 2023-24 Rules adopted without change.

### **LEGAL METHODS:**

- Reptiles hand or noose, set of tongs or snake hook
- Amphibians hand or dip net

ILLEGAL METHODS: crowbar, tire iron, jackhammer, winch, explosive device, chemical substance or method that destroy habitat, pit or can trap

## BALD EAGLE AND GOLDEN EAGLE

BANS killing, destruction, wounding, trapping, injuring, possession and capturing bald and golden eagles.

- EXEMPT:
  - Permits for those seriously injurious to wildlife or agriculture
  - Golden eagle obtained from wild by master falconer for rehabilitation, obtained from another state under federal law, possessed in another state before moving to NV, or transferred from another falconer with department approval – NEED Eagle Permit (SB 125/Chapter 233 Signed into law 5/30/21 - Effective 10/1/21)

## WILD HORSES

BANS removing wild horses from public lands along with converting to private use, killing or harassing, using aircraft or motor vehicle to hunt, polluting watering hole to trap, making remains into product or selling wild horses that stray on private property.

# AQUATIC INVASIVE SPECIES AND INJURIOUS AQUATIC SPECIES

Allows commission to prohibit import, transport and possession of aquatic invasive species and injurious aquatic species.

## **SWAP MEETS**

BANS sales of animals at swap meets.

- EXEMPT:
  - In county or incorporated city with ordinance allowing it that includes provisions similar to state operator law and does not allow animal cruelty if sold under ordinance
  - Sale or transfer of livestock
  - Livestock auction or agricultural implements
  - Outdoor event by shelter or rescue adopting out dogs and cats
  - Adoption or ownership transfer where fee not charged and animal has all appropriate vaccinations

(NRS 574.550)

# **IMPORT (AGRICULTURE)**

• Livestock = all cattle or bovines, all equines, all porcine species (swine), all caprine species (goats), all ovine species (sheep), all poultry or domesticated fowl or birds, dogs, cats and other domesticated animals, alternative livestock

BANS import of foxes, skunks and raccoons.

BANS import of live elk, mule deer, white-tailed deer, moose, alternative livestock or other animal declared susceptible to CWD that is added.

- EXEMPT: alternative livestock permit
- North American elk need negative Brucellosis test within 30 days prior
- Other domesticated cervids need negative TB and Brucellosis test within 30 days prior

Health certificate required for other animals.

• Exotic and wild birds need DOW permission
