# TENNESSEE LAWS

### UAPPEAL

### LIVE WILDLIFE

All live native and exotic live wildlife is divided into classes:

- Class I (inherently dangerous species)
  - LIMITED TO: zoos, circuses, commercial propagators
  - GRANDFATHERED: owners 1991 with personal possession permit and lineage up to 3 animal per species
    - need permit for offspring within 12 months or give to commercial propagator or other legal entity
- Class II (unlisted native species)
- Class III (NO PERMIT required)
- Class IV (restricted native species)
  - LIMITED TO: zoos and temporary exhibitors and authorized rehabilitators
- Class V (injurious to environment)
  - LIMITED TO: zoos

### PERMITS:

- Personal Possession Permit (grandfathered Class I; Class II)
  - EXEMPT: bobwhite quail, non-native game birds released for hunting, waterfowl, native aquatic species in aquaria, native nonpoisonous reptiles and amphibians
    - Other permits apply
- Transfer of Ownership (transfer Class I or II under personal possession permit)
- Commercial Propagator Permit (Class I)
- Propagation Permit (Class II)
  - EXEMPT: fish dealer's license
- Importation Permit (import wildlife)
  - EXEMPT:

- Class III, zoos, temporary exhibitors, falconry raptors
- Native fish, triploid grass carp certified by USFWS, species approved for fish farming, golden orfe
- Temporary Exhibitor Permit (Class I, II, IV up to 30 days)
- Permanent Exhibitor Permit (Class I or II)
  - ALSO NEED: commercial propagators license for commercial trade
- Commercial Wildlife Preserve Permit (release pen-raised/farm-raised game for hunting)
  - EXEMPT FROM: hunting permit
  - BANS big game after 2009, Class I, white-tailed deer, wild turkey, black bear, endangered/threatened species
- Falconry Permit
- Zoos, Nature Centers, Rehabilitation Centers, and Educational Exhibits Certified As Nonprofit
  - o BANS Class III wildlife and holding other wildlife permits except for zoos

LISTS: Unlisted hybrids are regulated as parent with least restrictive class

- INCLUDES: Elk for farming
- EXCLUDES: all other elk Class II wildlife
- Elk in eastern grand division need documentary evidence of origin
- Exotic furbearing mammals for fur (revised by TWRA)
- Class IV:
  - Black bear
  - White-tailed deer
  - Wild turkey including eggs
  - Hybrids of Class IV species except bobcat
  - Animals morphologically indistinguishable from native Class IV wildlife
- Class V: (TWRA)
  - Nandaya or Black-Hooded parakeets
  - Quaker or Monk parakeets
  - African clawed frog
  - Zebra mussels
  - Black carp
  - Blueback herring
  - o Ruffe
  - Bighead carp
  - Silver carp
  - Snakeheads (Channidae)
  - New Zealand mud snail
  - o Round goby
  - o Rudd
  - Swamp eels (Synbranchidae)
  - o Marbled crayfish
  - o Gold Asian clam
  - o non-native freshwater aquatic life
    - EXCLUDES:
      - triploid grass carp certified by USFWS
      - species approved fish farming
      - fish, crustaceans and mollusks in aquaria not listed above

### CLASS I REQUIREMENTS:

- 21 or older
- 2 years of experience or 70% or better score on a written exam
- Facility on premises where permit holder lives or full-time resident caretaker
- 1 acre for personal possession or 3 acres for commercial propagators no multi-unit dwelling
- recapture plan and equipment, caging and care requirements for stationary and mobile facilities, liability for escapes and immediately notify of escapes

- notify of transfer within 5 days and new owner must have proper facilities beforehand proven by permit or letter showing inspection
- propagation limited to commercial propagators and only allows sales to legal entities
- microchip within 6 months or 7/1/2018 for ones owned before 7/1/15
- temporary exhibitors need itinerary at least 21 days before 1st event
- Permanent exhibitors offsite require 24 hours' notice
- Allows public contact with cats and bears less than 25 pounds and less than 3 months if not exhibited more than 1 hour per every 8 hours and ensure good animal health
  - off-site exhibits require 3 days' notice

#### OTHER REQUIREMENTS:

- Federal and state endangered/threatened must be legally imported or by an exempt person (see Nongame and Endangered Species)
- Class I and II need documentation of supplier and date of acquisition, inspections, permit per location for propagation or sales, approval to add new species to permit
- Notify of personal injuries inflicted requiring medical treatment within 48 hours and give report
- Need proof of legal ownership
- Import must come from USDA dealer if from interstate commerce, shipper's copy of permit for carriers, notify regional office 24 hours before (release only), legally obtained from origin
- Wild-caught only legal if allowed by law
- Need approval to release: bobwhite quail, red and gray fox, raccoon, nonnative game birds, mallards, native fish not approved for fish farming for private ponds and lakes, cottontail rabbit
  - EXEMPT: fish farming approved fish for private ponds and lakes
- Zoos must be AZA or official zoo of political subdivision and have 100,000 visitors annually BANS sale to general public
- Nature centers must educate the public about native ecosystems and may maintain Class II for educational purposes wild-caught must be no charge
- Rehabilitation centers may rehabilitate Class II and IV wildlife except turkeys and meet several requirements
  - allows reference from someone knowledgeable in animal husbandry, black bears must be determined to be eligible for release and follow mobile transport rules

### SKUNKS

BANS import, possession, sale, barter and exchange of live skunks.

- EXEMPT:
  - o bona fide zoological parks and research institutions
  - o wildlife rehabilitator for rehabilitation and release

## AQUATIC LIFE EXCEPT GAME FISH

BANS take of fish, mussels, turtles or other aquatic life other than game fish.

- EXCEPTIONS:
  - Allows commercial sale with limitations
  - Take on designated waters for commercial use

(Tenn. Code Ann. § 70-4-119)

## FISH FARMING, CATCH-OUTS, BAIT DEALERS

PERMIT (Fish Dealer's License) required for fish farms, catch-out operations and bait dealers.

FISH FARMS: rear and sell approved fish and aquatic life in private facilities

- Need invoice for all sales or disposals

### CATCH-OUT OPERATIONS: allow customers to catch aquatic species through sports fishing and purchase

- Fish must be captive bred or caught by commercial fishers
- Invoice for sales and disposals
- LIST: Approved Species
  - Rainbow Trout
  - o Brown Trout
  - Atlantic Salmon
  - Channel Catfish
  - Blue Catfish
  - Flathead Catfish
  - Common Carp
  - Triploid Grass Carp certified by USFWS
  - o other aquatic life with written approval

BAIT DEALERS: capturing and selling aquatic life for bait

### **OTHER PERMITS**

- Wildlife Capture, Transport and Release Permit (capture and release red and gray fox, raccoon, bobwhite quail)
  - EXEMPT: Nuisance Animal Damage Control Rule and landowners on own land
- Scientific permits (take, capture, transport wild birds/animals/fish for science)
- Stocking permits
- Peregrine Falcon Take Permit (take by General Class/Master Class) Issued by random drawing

### **PROTECTED WILDLIFE**

BANS barter, sale, transfer and purchase of protected wildlife unless allowed.

(Tenn. Code Ann. § 70-4-201)

## NONGAME AND ENDANGERED SPECIES

BANS take, possession, transport, export and shipment of state endangered and threatened species, federal native endangered species as of 1974 (unless any changes specifically approved) and federal foreign endangered species.

- EXEMPT:
  - o scientific, zoological, or educational purposes, propagation in captivity or other purposes
  - wildlife legally imported except federal native endangered species
- INCLUDES: species determined to be very similar to listed species

BANS take, possession, transport, export, processing, sale or offer for sale and shipment and for common and contract carriers to knowingly receive or transport nongame wildlife.

• EXEMPT: as allowed by rule

### COMMERCIAL USE OF WILDLIFE

BANS commercial use of endangered species.

Threatened species and in need of management species only allowed for commercial use if legally imported for sale and as allowed for scientific, zoological, or educational purposes, propagation in captivity or other

approved purposes.

LEGAL to sell:

- Live crustaceans for food
- Imported/propagated amphibians other than bait
- native and non-native species if allowed by law
- certain parts and products

## WILD-APPEARING SWINE

BANS transport or release of wild-appearing swine without Department of Agriculture documentation.

(Tenn. Code Ann. § 70-4-133)

## **CANINE/FELINE HYBRIDS**

Canine and feline hybrids less than 25% wild are considered domestic dogs and cats under the rabies law which requires a rabies vaccine by 6 months. However, hybrids may be vaccinated if vaccine is legally available for the species.

(Tennessee Code 68-8-101 to 103)

## **EXHIBITION AND IMPORT (Agriculture)**

 Domestic animal = includes cattle, bison, horses, mules, asses, sheep, goats, swine, dogs, cats, avian species, and Class III animals PERMIT (Entry Permit) required to import pet swine and cervids.

Certificate of veterinary inspection required to import domestic animals and to exhibit camelids and captive cervids.

#### **REQUIREMENTS:**

- Pet swine identification, quarantine 60 days after shipment if ordered AND negative Pseudorabies and Brucellosis 30 days prior OR from Validated Brucellosis-Free and Qualified Pseudorabies-Negative herd
- Wild-appearing swine
  - Import USDA metal tag or other ID, negative Pseudorabies and Brucellosis within 30 days prior OR from Validated Brucellosis-Free and Qualified Pseudorabies-Negative herd
  - In state transport metal tag or ID AND 1 of these: negative Pseudorabies and Brucellosis within 90 days prior, from Validated Brucellosis-Free and Qualified Pseudorabies-Negative herd, or movement authorization by state vet for slaughter or market
- Cervids
  - Import 2 forms of ID including USDA official one and meet CWD and TB requirements
  - In state transport CWD susceptible need authorization if from county within 10 miles of CWD detection and 2 IDs; non-susceptible need 2 IDs for markets
