During travel to and from your destination we recommend that the Device be stored inside in the packaging supplied by Getting Places Safely
- 2. The User agrees to ensure that the Device is covered for total loss by means of the Users travel insurance or other insurance policies held by the User. In the event of loss or theft of the Device the User agrees to complete any procedures required by the Users insurance. In any case, in the event of damage or loss, the User agrees to remedy such loss, in full with the Supplier as detailed in paragraph 4.
- 3. The User agrees to safely return the Device to the Supplier in good working order within 3 days of the end of the Period of Hire.
