



Juggernauts Training Waiver Form

ACTIVITY DESCRIPTION

Juggernauts Mobile Football Trainer provides football training services using professional-grade JUGS football passing machines at various locations, including but not limited to private residences, parks, schools, community fields, or partner facilities (e.g., gyms). Training includes high-repetition drills to improve catching, reaction time, and other football skills, utilizing machines that deliver high-speed passes and contain rotating motors and components

ACKNOWLEDGEMENT OF RISK

I understand that participation in football training with Juggernauts Mobile Football Trainer involves inherent risks, including but not limited to muscle strains, sprains, fractures, concussions, bruises, or other injuries resulting from physical exertion, contact with equipment, or environmental conditions (e.g., uneven surfaces, weather). I specifically acknowledge the risks associated with the JUGS football passing machines, which propel balls at high speeds and contain rotating motors and mechanical components that may cause injury if improperly used or if safety protocols are not followed. Additional risks include potential impact injuries from high-speed balls, entanglement or contact with moving parts, or equipment malfunctions. I acknowledge that training may occur at locations not owned or controlled by Juggernauts, which may introduce further risks. I confirm that I (or the minor participant) am physically capable of participating and have no medical conditions that preclude safe involvement, or I have disclosed any relevant conditions to Juggernauts in writing.

ASSUMPTION OF RISK

I voluntarily assume all risks associated with participation in Juggernauts Mobile Football Trainer activities, including those related to the high-speed operation of JUGS machines, rotating equipment, and training at various locations, whether conducted at my chosen site or a partner facility.

RELEASE OF LIABILITY

In consideration of being permitted to participate in Juggernauts Mobile Football Trainer activities, I, for myself (or on behalf of the minor participant), my heirs, executors, and assigns, hereby release, waive, and discharge Juggernauts Mobile Football Trainer, its owners, employees, contractors, affiliates, and partner facilities (including gyms hosting JUGS machines) from any and all liability, claims, demands, or causes of action for personal injury, property damage, or other losses arising from participation in training activities, including those related to the use of JUGS machines, except in cases of gross negligence or intentional misconduct.

HOLD HARMLESS AGREEMENT

I agree to hold harmless Juggernauts Mobile Football Trainer and its affiliates from any claims, damages, or legal fees arising from my (or the minor participant's) participation, including claims brought by third parties. This includes risks associated with high-speed balls and rotating equipment in JUGS machines, as well as environmental conditions at training locations.

GYM PARTNERSHIP AND REVENUE SHARING AGREEMENT

I understand that if training occurs at a partner gym or facility hosting a JUGS machine under a revenue-sharing agreement with Juggernauts Mobile Football Trainer, additional risks may arise from the gym's environment, including but not limited to facility conditions, other equipment, or third-party users. I acknowledge that Juggernauts provides the JUGS machine and training protocols, but the partner facility is responsible for maintaining a safe environment. I release and hold harmless Juggernauts Mobile Football Trainer from liability for injuries or damages arising from the gym's premises or operations, except in cases of gross negligence or intentional misconduct by Juggernauts. I agree to comply with any additional safety rules or procedures set by the partner facility.

MEDICAL RESPONSIBILITY

I confirm that I (or the minor participant) am in good health and have no medical conditions that would prevent safe participation, or I have disclosed such conditions to Juggernauts. I authorize Juggernauts staff to seek emergency medical treatment for me (or the minor participant) if necessary, and I agree to cover any associated costs.

PARENTAL/GUARDIAN CONSENT (IF APPLICABLE)

As the parent or legal guardian of the minor participant named above, I consent to their participation in Juggernauts Mobile Football Trainer activities, including at partner gyms. I acknowledge the risks described above, including those related to high-speed balls and rotating equipment, assume those risks on behalf of the minor, and agree to the release of liability and hold harmless terms on their behalf.

PHOTO/VIDEO RELEASE

I grant Juggernauts Mobile Football Trainer permission to use photographs or videos of me (or the minor participant) taken during training for promotional purposes, including on social media, websites, or marketing materials, unless I opt out in writing.

TERMS OF WAIVER

This waiver applies to all training sessions conducted by Juggernauts Mobile Football Trainer, including individual sessions, group clinics, subscription packages, or gym-hosted programs, for the duration of my (or the minor participant's) involvement, unless revoked in writing.

ACKNOWLEDGEMENT

I have read and understand this Waiver and Release of Liability. I acknowledge that I am signing it freely and voluntarily, and I understand that it affects my legal rights. If any portion of this agreement is deemed unenforceable, the remaining provisions shall remain in effect.
