- **I. Call to Order**: President Mark Aslakson called the meeting to order with a double tap of the gavel promptly at 6:30 p.m.
- **II. Secretary's Report**: Brenda Maughan emailed August's minutes prior to the meeting. Kara Kalbus made a motion to approve August minutes and Amanda Kaldor seconded. Minutes approved.
- III. Treasurer's Report: Shannon Gephart provided all recent bank statements. Currently, \$20,882.19 balance in checking and \$91,628.76 in savings. A large deposit in checking was due to PTSA asking Booster Club to "hold" onto Post Prom funds temporarily. Other items of note were volleyball and boys' tennis fundraisers. As a reminder, Booster Club processes these fundraisers and 80% goes to the organization with Booster Club keeping 20%. Also to note for recording purposes, Shannon met with auditors for the yearly audit (which had to be complete by Sept. 30th) and gave detailed reports of Booster Club finances. Mark Aslakson said he will go over the pre-approved guidelines during our next meeting. A motion to approve the treasurer's report was made by Jack Maughan and Llnn Webb seconded. Report approved.

IV. Committee Reports -

- A. **Hospitality & Spirit** An upcoming event will be the Member Appreciation/Football Tailgating BBQ on Sept. 12th. A sign up genius will be sent out to ask board members to volunteer for this large event in the areas of setting up, serving and cleaning up.
- B. **Registration** Membership numbers seem to be on track compared to previous years. Lots of people have picked up their swag. We have learned that Go Fan is non-transferable. Of note: IPads have not worked well for registration this year. Dan Shultis is checking with FPS IT and will hopefully get the problem with School Pay fixed. If not, Dan could repurpose the iPads and we'll continue to use the computer. Also of note from Dan: We need to look at how we solicit membership. For example, the donor of the weight room mentioned he wasn't solicited for membership. We need to also look at elementary and middle school parents.
- C. Advertising Continues to work on sign renewal and has calls into many asking to renew. We do have 3 sign openings (FB field; track & field; corner of 10th St/19th Ave).
 Bergseth is contacting Western Products. The question arose of how we give business

- access to admission passes. Dan Shultis said maybe we can do a temporary fix. A corporate option may need to be created. More to follow on this.
