- A. Stadium Chairs Dan Shultis shared that BSN will provide the huge cost for these.
- B. Fitness Center Graphic To be discussed during New Business.
- C. Charitable Gaming Update Blair Thoreson has not met yet with Dobberstein from Hector Airport.

## VII. New Business

- A. Streaming Sponsorship Info Dan Shultis shared that a few companies are interested in advertising through Hudl streaming of FN events which would be financially beneficial. The issue is complicated for multiple reasons, and Dan will be discussing it with the district. (Ex. Davies does not have Hudl). Adam Kaldor brought up the issue of no camera in our Activity Center for streaming.
- B. **Sanford Health** Dan Shultis is working with Sanford and FPS to secure a lit up sign on the back side of the track. Sanford has not committed a dollar amount, but talks have been positive.
- C. Tennis Wind Screens Dan Shultis shared details regarding tennis courts and their care. Fargo Parks cares for Elephant Park. Long term plan is a remodel for FN courts in 5-6 yrs., but for now we are in need of wind screens (old ones have gotten demolished by weather; originally purchased with COVID funds). FN can contribute \$2,000. Booster board ask would be \$5,000. Webb's also contributed to the discussion as current tennis parents and explained the great need for these. Tyler Tracy made a motion to fund the wind screens and Amanda Kaldor seconded. Motion passed.
- D. **Wrestling Mats** Dan Shultis shared in a previous meeting that the wrestling practice mat was updated by the district. He is looking to update the side walls which are royal blue and will need replacement. No action needed today.
- E. **Harry Holland Painting Project** Dan Shultis was looking for any northside recommendations for a painter who might be interested in painting the building navy blue. The roof was redone.
- F. Volleyball Fundraiser will occur soon and will be funnelled through the Booster Board.
- G. Fan Appreciation Nights We did not finalize any dates yet.
- H. **Spartacus Dance** Eight individuals will head to nationals this winter. The group is requesting \$3,000 to obtain a choreographer. We discussed funding it fully or if the group was willing to raise some of their own funding. Wade Webb made a motion to give \$2,000 to the group and Jenaah Hanson seconded. Motion passed.
- I. **Miscellaneous Items:** Linn Webb shared that PTSA will no longer be doing Post Prom. Also, we are continuing to work on apparel for new board members.
