### **1. Acknowledgment of Risk**

I, the undersigned, acknowledge that I am voluntarily leaving my dog(s) in the care of Duntroon Dogs, hereinafter referred to as the "Boarding Facility." I understand that participation in dog boarding services may involve risks, including but not limited to injury, illness, or behavior-related issues such as aggression or stress that may arise while in the care of the Boarding Facility.

### **2. Health and Behavior of Pet(s)**

I affirm that my dog(s) is/are in good health and free from contagious diseases or conditions. I agree to inform the Boarding Facility of any medical conditions, medications, allergies, or behavioral issues that may affect my dog(s). I acknowledge that failure to disclose such information could result in harm to my dog(s) or other dogs at the facility.

### **3. Emergency Medical Treatment**

In the event of an emergency where my dog(s) require medical treatment, I give the Boarding Facility permission to seek veterinary care. I understand that any medical expenses incurred will be my responsibility and that the Boarding Facility will not be held liable for any costs or damages related to medical treatment.

### **4. Liability Waiver**

I, on behalf of myself, my heirs, and assigns, hereby release and hold harmless the Boarding Facility, its owners, employees, agents, and affiliates from any and all claims, demands, losses, or damages arising out of or in connection with my dog(s) being boarded, including but not limited to injuries, illness, or death of my dog(s), damage to property, or injury to third parties.

### **5. Behavior of Dog(s)**

I acknowledge that the Boarding Facility may, at its discretion, refuse service or request that my dog(s) be removed from the premises if the behavior of my dog(s) is deemed unsafe or unmanageable. I agree to cover any associated costs or expenses, including but not limited to, transportation or boarding at an alternative facility.

**6. Photography and Media Release**

I consent to the use of photographs, videos, or other media taken of my dog(s) while boarded at the facility for marketing or promotional purposes, unless I explicitly opt-out in writing.

**7. Indemnification**

I agree to indemnify and hold harmless the Boarding Facility from any and all liability, including legal fees, arising from any claims, lawsuits, or disputes caused by my dog(s) during their stay.

**8. Governing Law**

This Agreement shall be governed by the laws of the Province of Ontario.

**9. Entire Agreement**

This waiver and release constitutes the entire agreement between the parties. Any modifications must be made in writing and signed by both parties.
