Richard T. - Tennessee - Justified Shooting / Changed to Homicide

After being given the run-a-round by the sheriff's office for Hardeman County, TN, our family began to look for a private investigator over the death of my brother-in-law. Seven months after Ricky's death, we finally contacted WhiteRaven Investigations. We told them of our frustrations and they truly listened. The County Sheriff had ruled the death as a justified shooting, claiming that Ricky, my brother-in-law, had broken into the shooter's home through the trailer's front door. Our investigator reviewed our statements and then travelled over 400 miles in order to examine the trailer's front door. Ricky's physical description had already been taken by WhiteRaven and compared to the trailer's door window. What the sheriff's office did not know and WhiteRaven Investigations did, was that trailers with diamond windows in the front door actually are a security door, because even the average sized man cannot reach through the broken window to open the door from the inside, like the shooter and his wife claimed Ricky had done. Ricky would have had to levitate 6 inches and his arms grow another 3 - 4 inches in order to reach the inside doorknob. This was later confirmed by a 6'1" T.B.I. – Violent Crimes agent, with the same results. WhiteRaven also collected actual evidence to prove Ricky had been shot elsewhere and then drug through the back door of the trailer, across the floor to his final resting place where deputies found him. WhiteRaven sprayed a luminal (BlueStar) inside the trailer and the result was startling. Equally astounding, and very much disquieting, was the night the WhiteRaven agent stood in our backyard at midnight, with no lights nearby, and began to spray Ricky's almost brand new pick-up

truck, on the plastic bed -liner of the truck, on the rear quarter panels, and inside the cab of the truck. There were six of us standing in the pitch black Tennessee midnight, unable to see a hand in front of our faces, let alone the persons next to us. The reaction to the chemical spray was immediate and startling - the night lit up bright blue. I could not only see the person next to me, I could see the people on the other side of the truck and clearly make out objects in our back yard. The WhiteRaven agent had found where Ricky's killing initially took place. The result was the sheriff's office releasing an official letter stating that Ricky's being killed was most likely a murder homicide. The case was taken away from the county and reviewed by Tennessee Bureau of Investigations and by the Tennessee Attorney General. WhiteRaven walked us through every step of it and they have renewed our faith in good people making things right. WhiteRaven's forensic examiners were able to review several computer hard drives and Kodak SD memory cards, finding that evidence had been removed from the computer while it was in the sheriff's office. WhiteRaven was able to recover the photos from the SD memory card and they produced a digital copy of a document belonging to the sheriff's office pertaining to chain of custody for evidence gathered at Ricky's home and where he had been killed. The sheriff's office had actually used the collected computer evidence to create their chain of custody form. The sheriff is no longer Hardeman County's law enforcement. The lead investigator on Ricky's murder case quit right before the sheriff was voted out. He joined a law agency in another county. Shortly after his being hired, he was caught intimidating high school girls into having physical relations with him. He was arrested and put in jail. Local F.B.I. agents contacted WhiteRaven for evidence WhiteRaven had collected against the HCSO during their investigation. We appreciate WhiteRaven Investigations.
