**DBC Equipment.** For purposes of this Agreement "DBC Equipment" shall mean any modems, antennas or other equipment installed at the Subscriber's property (the "Property") or provided to Subscriber in connection with providing the Services under this Agreement. Subscriber hereby agrees that any and all DBC Equipment installed on or around the Property that is used in connection with providing the Services is and shall remain DBC's separate personal property, and that said DBC Equipment shall never be considered fixtures to the real estate. DBC shall at all times be authorized to remove the DBC Equipment from the Property, free from any lien of Subscriber or other third party. DBC shall be authorized during normal business hours to access the Property to repair, maintain or remove the DBC Equipment without additional consent from Subscriber. Subscriber shall be charged the applicable Non-Returned Equipment Fee listed above if Subscriber fails to return all DBC Equipment to DBC in good working order within 10 days of the expiration or termination of the Services.

**Limitations on Use of Services.** Subscriber is expressly prohibited from providing Services to any person or entity that will resell, remarket or sublease the Services including but not limited to sales agents, retail outlets or wholesale distributors. The Services shall be limited to use within the Property.

**Advertising Rights.** Subscriber hereby grants DBC, and DBC's agents, the right to use the Subscriber's trademarks, service marks, name and address for the sole purpose of advertising the existence of a Hotspot or other DBC Services on the Property.

**Authorized Use.** Use of the Services shall be governed by DBC's Terms and Conditions (the "DBC Terms and Conditions") which are posted on DBC's website at [www.digitalbridgecommunications.com](http://www.digitalbridgecommunications.com) and are incorporated by reference into this Agreement.
