Executive Summary:

- The HOA is in a stable financial position with \$27,786 cash on hand and a projected year-end balance of \$11,220 \$14,000. Key updates include amended CC&Rs, a new enforcement resolution, and a change in landscaping company resulting in \$2,000 savings.
- Brandon, Jeff, and Dave were elected as board members. The Architectural Control Committee and Irrigation Committee welcomed new volunteers, with plans to address ongoing irrigation issues.
- Community members were informed about an upcoming fire department levy vote on May 20th, requesting \$2.25 million to fund 12 firefighters and improve response times. The HOA is also addressing irrigation system problems, including algae-clogged screens and potential future treatments.

- Voting results: 80% in favor for amendments 1, 2, 3, and 5; 79% in favor for amendment 4

Enforcement Resolution

- New enforcement resolution created to outline fines and fee structure
- Available on website under documents tab

- Fines based on percentages of annual assessment (e.g., 25% for ACC violations, 50% for CC&R violations)
- Includes notification schedules and timelines for disputes in accordance with Idaho Code

Treasurer's Report

- Current cash on hand: \$27,786
- Remaining association income (installment payments): \$3,283
- Projected year-end balance: \$11,220 \$14,000
- Steven Springs Irrigation Issues:
 - o \$1,600 repair needed for algae-clogged screen (HOA responsible for 40%)
 - o Discussing potential algae treatment with Steven Springs HOA to prevent future issues
- Bad debt reserve of \$1,780 expected to be recovered

Secretary's Report

Swale Repair Process

- Ongoing flooding issues in cul-de-sac during rain/snow melt
- Process for reporting to ACHD:
 - o Visit ACHD website, go to "My Commute", click "Report an Issue"
 - o Minor maintenance is HOA responsibility
 - Major flooding issues are ACHD responsibility
- Brandon has submitted multiple requests since January, will continue to follow up

Landscaping Updates

- New landscaping company: Summer Lawns
 - Saved HOA \$2,000 compared to previous provider
 - o Cleaned up tree canopies and opened up view of waterfall
 - o Plans to remove broken tree near park
 - Removing large juniper bushes at subdivision entrance for safety, replacing with smaller shrubs
 - o Using pre-emergent granular treatment in flower beds to suppress weeds
- Homeowners encouraged to report any landscaping issues to the board

Committee Reports

Architectural Control Committee (ACC)

- Four projects approved since August of the previous year:
 - o Pergola and flatwork for patio
 - Greenhouse
 - Fence coloration
 - Tree removal
- One project denied (details not specified)

Irrigation Committee

- Several issues reported this year:
 - o Multiple homeowners required repairs before system turn-on, causing delays
 - o Recent issue with Steven Springs Pond being plugged up
 - o Diver scheduled for repairs, water expected to be available by Wednesday
- Discussing algae control measures with Steven Springs to prevent future issues
- Some swale irrigation lines may need maintenance or repairs
- Brandon to review irrigation system components and timers with Summer Lawns

Social Committee

- Recent events:
 - o Community garage sale (smaller turnout than previous year)
 - o Opened event to artisans and crafters (no participants this year)
- Upcoming events:
 - o Fourth of July flag display throughout the park
 - o Considering a summer picnic
