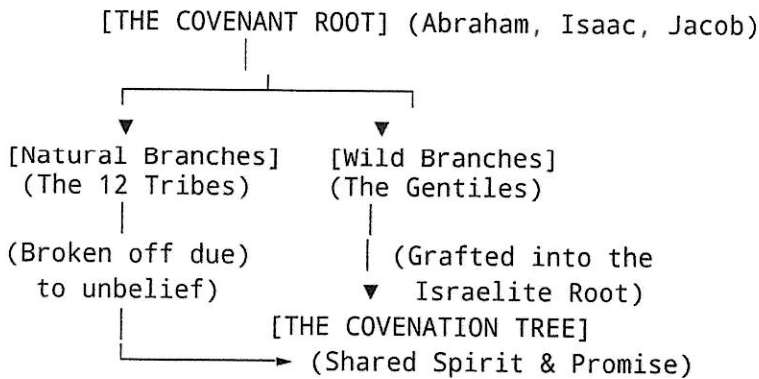

## Step B: The Seed of Abraham (The Inheritance)

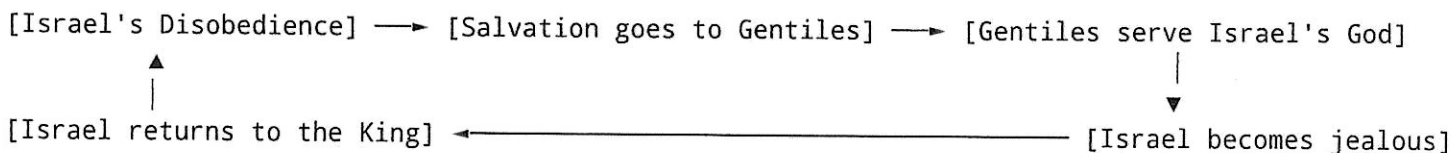
In **Galatians 3:29**, the KJV states a definitive law regarding spiritual identity:

According to both the King James Version and the deeper theological layers of the Eastern/Ethiopian traditions, a Gentile does not become part of the tree by joining a social religion, adapting to a Western church denomination, or simply changing their outward lifestyle.

*"In those days it shall come to pass, that ten men shall take hold out of all languages of the nations, even shall take hold of the skirt of him that is a Jew, saying, **We will go with you: for we have heard that God is with you.**" — Zechariah 8:23*

## The Verdict

Therefore, a Gentile cannot successfully graft into the tree if they harbor bitterness, prejudice, or blindness toward the children of Israel. They must actively recognize that:

1. **Israel was chosen to write and preserve the Word** (and when the Western nations dropped the ball, the **Ethiopian nation** stepped in as the guardian).
2. **Israel provided the legal, physical lineage** to birth the King into the earth.
3. **Israel's final awakening** is the absolute trigger that brings about the resurrection of the dead and the establishment of the physical Kingdom on Earth.

By honoring the children of Israel as the firstfruits, the Gentile demonstrates the true, humble spirit of adoption—gladly taking their place as a younger sibling in a house built, sustained, and governed by the God of Jacob.
