24th Annual Juried Winter Arts Festival Art Show 2021

January 27 to February 27, 2021

Eligibility

Artists are welcome to submit up to two entries (may be 2D or 3D) created within the past two years and not previously exhibited in the Winter Arts Festival. Artwork must be original work by the entering artist. All entries must be for sale. All entries are subject to the discretion of Gallery Uptown. Any entry found to be unacceptable or offensive will not be included in the show. Entrants must be 18 years or older with the exception that minors may enter with the signature of parent or adult guardian on this form.

About the Juror: Catherine Mott

Catherine (Cathy) Mott is the Assistant Director at the Muskegon Museum of Art (MMA). Prior to this position she was the Curator of Education at the MMA for 10 years. She received her Bachelors of Art degree in art history with a math minor from Saint Mary's College, Notre Dame, Indiana. She interned and worked at the South Bend Regional Museum of Art, and prior to her current position at the MMA, she was the Director of the Nuveen Community Center for the Arts. Cathy has been the project manager for numerous large grants and has worked with many internationally recognized artists. She was in charge of creating a hands-on design education center that coincided with Good Design: Stories from Herman Miller, a traveling exhibition produced by the Muskegon Museum of Art. For over 13 years she has dedicated her career to making the MMA accessible to all. Cathy currently resides in Montague with her husband, Jared, and two daughters, Vera and Eliza.

Artwork Entry & Delivery Instructions

- Artists must complete the attached Entry Form/Notification Card.
- “Entry A” and “Entry B” labels should be affixed to their respective artwork on the reverse side of each entry.
- Artwork must be dry and ready to hang. Please, no sawtooth hangers as they do not work well with our hanging system. No exposed glass or plexiglass edges allowed. All artwork must be able to be handled/moved by two people.
- Deliver artwork on:
Wednesday, January 20 through Friday, January 22, 2021 from 10 to 5:30
Saturday, January 23, 2021 from 10 to 4.
- Accepted artwork must remain on exhibit until the end of the show

Artwork Pick Up Instructions

- Pick up of declined artwork: **Tuesday, January 26, 2021 from 10 to 5**
- Pick up of accepted artwork: **Sunday, February 28, 2021 from 1 to 4**
- Please bring identification when retrieving artwork
- If you intend for someone else to pick up your artwork, you must send a release note including your signature and the title of the work to be released.

Entry Fee

Non-refundable entry fee is \$30 for up to two eligible works. Please pay by cash or check payable to Gallery Uptown.

Notification

We will notify you about the status of your submission by email. If you would prefer notice by U.S. Mail, then please include a SASE with your entry. The juror’s decisions are final.

Sales & Commission

All artwork must be for sale. Gallery Uptown retains 35% commission on all sales.

Liability

We strive to keep all artwork safe and secure, but in case of loss or damage Gallery Uptown will not be held liable. Gallery Uptown may photograph artwork for use in promotion, publicity, and marketing. Submission of this application constitutes agreement with all conditions herein.
