1. RELEASE AND WAIVER OF LIABILITY. In consideration of being permitted to register for, enter, attend, practice for, launch for, weigh fish at, or otherwise participate in any Lone Star Bass Series tournament or related activity (collectively, the "Activities"), I knowingly and voluntarily RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE Lone Star Bass Series, its directors, tournament officials, volunteers, members, partners, sponsors, affiliates, agents, representatives, property owners, ramp or marina operators, and their respective successors and assigns (collectively, the "Released Parties") from claims, demands, causes of action, damages, losses, liabilities, costs, or expenses arising from or relating to my participation, including bodily injury, illness, disability, death, or property loss or damage, to the fullest extent permitted by law.

2. ASSUMPTION OF RISK. I acknowledge that competitive bass fishing, boating, trailering, launching, navigation, fishing from a vessel, weather, water, wildlife, submerged objects, other vessels, equipment, ramps, docks, and travel to or from an event involve inherent and other risks that may cause serious injury, permanent disability, death, or property damage. Such risks may be known or unknown, foreseeable or unforeseeable. I voluntarily choose to participate and knowingly assume all such risks and responsibility for resulting injury, loss, or damage.

3. INDEMNIFICATION AND HOLD HARMLESS. To the fullest extent permitted by law, I agree to INDEMNIFY, DEFEND, AND HOLD HARMLESS the Released Parties from claims, liabilities, damages, judgments, losses, costs, and expenses, including reasonable attorneys' fees, arising from my acts or omissions, violation of law or tournament rules, damage caused by me, or my participation in the Activities, except to the extent prohibited by applicable law.

4. MEDICAL TREATMENT, INSURANCE, AND EXPENSES. I understand that Lone Star Bass Series does not undertake to provide medical care, rescue services, insurance, or payment of medical expenses. I am solely responsible for maintaining any health, accident, vehicle, boat, liability, or other insurance I consider appropriate and for medical, rescue, towing, repair, or related costs incurred in connection with my participation.

5. RULES, LAWS, AND SAFETY REQUIREMENTS. I agree to become familiar with and comply with all current Lone Star Bass Series rules, tournament-director instructions, posted restrictions, off-limits or restricted areas, boating and fishing regulations, and applicable local, state, and federal law. I understand violations may result in penalties, disqualification, removal from an event or series, forfeiture of fees or awards where authorized by the rules, or other consequences provided by tournament rules.

6. PERSONAL RESPONSIBILITY AND FITNESS TO PARTICIPATE. I represent that I am competent to execute this Agreement and will exercise independent judgment regarding weather, water conditions, vessel operation, equipment, and my ability to participate safely. I accept responsibility for my conduct, equipment, vessel, passengers, and property. Nothing in this Agreement requires me to participate or continue participating when I believe conditions are unsafe.

7. BINDING EFFECT; TEXAS LAW; SEVERABILITY. It is my express intent that this Agreement bind me and, to the fullest extent permitted by law, my spouse, family members, heirs, estate, personal representatives, executors, administrators, successors, and assigns. This Agreement shall be governed by and construed under the laws of the State of Texas. If any provision is held invalid or unenforceable, the remaining provisions shall remain effective to the maximum extent permitted by law.

ACKNOWLEDGMENT OF UNDERSTANDING AND VOLUNTARY EXECUTION

I ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS AGREEMENT IN ITS ENTIRETY, UNDERSTAND ITS TERMS, UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING CERTAIN RIGHTS TO BRING CLAIMS AGAINST THE RELEASED PARTIES, AND SIGN IT FREELY AND VOLUNTARILY. I HAVE HAD THE OPPORTUNITY TO ASK QUESTIONS AND TO SEEK INDEPENDENT LEGAL ADVICE BEFORE SIGNING. NO ORAL STATEMENT, REPRESENTATION, OR INDUCEMENT NOT EXPRESSLY SET FORTH HEREIN HAS BEEN RELIED UPON BY ME.
