SPAY/NEUTER AGREEMENT

TERMS & CONDITIONS



At Sinala Cockapoos, we are dedicated to ethical and responsible breeding. To protect the health of our dogs, maintain breed standards, and reduce the risk of irresponsible breeding, puppies sold to pet-only homes are placed under a Spay/Neuter Agreement.

This agreement outlines the buyer's obligation to sterilize their dog within a set timeframe.

Pet-Only Puppy Placement

- Puppies sold as pet companions (not for breeding or show purposes) are subject to a mandatory spay/neuter agreement.
- These puppies are priced accordingly and will not be sold with breeding rights or full KC registration (if applicable).

Spay/Neuter Timeframe

- The buyer agrees to have their dog spayed or neutered by the age of [insert range, e.g., 6–12 months], unless a written exemption is provided by a licensed veterinarian.
- Proof of sterilization must be submitted to Sinala Cockapoos no later than [insert age/deadline].

Proof of Procedure

- Acceptable proof includes a signed certificate or invoice from a licensed veterinary practice confirming the date and type of surgery.
- This documentation must be sent via email or post for our records.

Delayed or Exempt Procedures

- If a veterinarian recommends delaying sterilization due to health or developmental reasons, the buyer must notify Sinala Cockapoos in writing with a vet-signed statement.
- In such cases, an extended deadline may be granted on a case-by-case basis.

Failure to Comply

- Failure to provide proof of spay/neuter by the agreed deadline may result in:
 - Legal action for breach of contract,
 - Revocation of ownership rights as outlined in the Puppy Sales Contract,
 - Recovery of the dog by Sinala Cockapoos, where legally permissible.
- We take this policy seriously to protect our dogs and our breeding ethics.

Breeding Rights Exception

- If breeding rights are requested, this must be discussed and agreed before purchase.
- Puppies sold with breeding rights will be covered under a separate Breeding Rights Agreement and will be priced and registered accordingly.

Buyer Acknowledgement

- By purchasing a pet-only puppy from Sinala Cockaposs, the buyer agrees to abide by this Spay/Neuter Policy and understands the importance of sterilization in preventing unwanted litters and promoting responsible dog ownership.

Health Benefits of Sterilization

- Spaying and neutering offer numerous health advantages, including reduced risk of certain cancers, prevention of unwanted behaviors (e.g., marking, roaming), and the elimination of heat cycles.
- Early sterilization can contribute to a longer, healthier life and better social behavior, particularly in multi-dog households.

Monitoring & Follow-Up

- Sinala Cockpoos reserves the right to follow up with the buyer around the time of the spay/neuter deadline.
- Buyers agree to provide updates upon request and cooperate fully with any verification procedures.

Non-Breeding Clause

- All puppies sold under this agreement are intended strictly as family pets.
- The buyer agrees not to breed, attempt to breed, or allow accidental mating to occur under any circumstances.
- Any breach of this clause may result in legal action and/or reclaiming of the dog.

Return of Puppy Due to Breach

- If the buyer fails to comply with this agreement or is found to have bred the dog without written consent from Sinala Cockapoos, the breeder reserves the right to request the immediate return of the dog.
- No refund will be issued, and legal costs related to enforcement may be pursued.
