Entries without payment will not be squadded. Entries must be received by **Sep 12, 2025**. Late entries (includes payment) will be subject to a \$15 late fee. **You are not registered until payment is received.**

Cancellations: After Sep 12 will **NOT** be refunded.

Rain Delay: There will be no rain-delay dates for these matches. Pre-registration fees will be returned in the case of match cancellation.

Eligibility: Participants must be TSRA members. Please put your current TSRA number on the entry form. Entries without TSRA numbers will be required to buy an annual membership or show your membership card on the day of the match. Out of state shooters may purchase a 3 day TSRA Pass for \$10.00 if they are a member of their home state Rifle Association. This pass is valid for the 3 days of the match only. Out Of State Competitors can win the TSRA State Championship. Click following link to join or renew <https://tsra.com/join/>

Capacity: The maximum range capacity is 52 (13 points x 4 relays). If the matches fill past capacity, post marks (payments received) will be used to determine squadding and a standby list will be developed. (2 firing point will be reserved as spare for target issues)

Waitlist: If the matches fill past capacity, a waitlist will be created and filled in the order received. **Do not pre-pay for Waitlist, payment will be accepted at the match.** The Late Fee will be waived for entries received before Sep 5. The Match Director will notify competitors as spots become available. If your entry number is **53 or above** wait for a confirmation email detailing whether you are Waitlisted or not, before sending payment.

Roll Call will be at **07:45 a.m.**
Firing will begin after roll call each day unless delayed due to weather.

RULES

Current NRA High Power Rifle Rules apply. Competitors are responsible for being aware of the Match Program and all safety regulations contained in the NRA rulebook or announced at the morning safety briefing.

Squadding:

The Championship Match will be pre-squadded with entry and Day 2 will be re-squadded based on Day 1 results.

Pit Service:

E-Targets will be used. Bring a smart phone or tablet. Competitors are still required to perform scoring duty.

Classifications:

NRA classifications will be used in all matches. Unclassified competitors will compete in the Master Class.

Challenges:

A \$2 Challenge Fee will be charged for lost challenges. Scores may only be challenged prior to awards. **Scorer must make all initial scoring decisions. The Score Challenge (Statistics) Officer's decision on challenges is final.**

Sighting Shots:

2 per stage - fired and scored in the individual matches.

Targets:

Rifle: 200 yd-SR, 300 yd-SR-3, 500 yd MR65.

Rifles:

Service Rifle as defined by NRA Rule 3.1
Match Rifle as defined by NRA Rule 3.3

Ammo:

Ammunition must be safe. Any defective or unsafe ammunition will be removed from the firing line. Any competitor that cannot get/stay on target will be removed from the firing line. For all matches on the 500-yard line 62 grain ammo and above must be used for 223/5.56mm. No tracers or AP are allowed. No calibers larger than 0.35.

Chamber Flags:

The use of an empty chamber indicator (ECI) is always required even while the rifle is in the case. Only during a preparation period or actual firing may the ECI be removed from the rifle.

<u>Magazines:</u>	Magazines and loading blocks may only be inserted in the rifle during the preparation period or live firing. "Short" magazines or loading blocks that comply with CMP Rule 4.1.(g) are not legal.
<u>Level Loading:</u>	Level-loading is required. Rifles must be pointed at the impact berm or lower while closing the bolt.
<u>On-Target:</u>	All competitors must be on-target in five (5) shots for all matches. Competitors that cannot comply will not be allowed to compete at that yard line
<u>Coaching:</u>	Coaching is not allowed during the Championship.
<u>Mobile Phones:</u>	Phone use (calls / texts / surfing the net / etc) is prohibited when firing or scoring. Use of cell phone to keep time is or use for scoring permitted.
<u>Challenge Period:</u>	The challenge period will be 30 minutes after the completion of each match. All awards and scores are tentative until publication of the official match results. The Statistics Officer will resolve all protests.
<u>Scoring:</u>	Competitors will score during all matches. Scorecards are to be turned in by scorekeepers following the competition of firing of each individual match. A scorer failing to turn in a score card may result in disqualification.
<u>Brass:</u>	All brass must be policed.
<u>Eye & Hearing Protection:</u>	<p>All competitors and competition officials, including Scorers or Verifiers, are required to wear eye and hearing protection when on shooting range firing lines during highpower rifle firing.</p> <p>Hearing protection cannot be used to listen to music or communications while on the firing line.</p>
<u>E-Target Scoring</u>	<p>Please read 10.17.2 Electronic Scoring Targets Rules in the latest revision of the NRA Highpower Rifle Competition Rules.</p> <p><i>For an insufficient shot (1) recorded on Rapid Fire Strings (M2/M3/M7/M8), provided there are no excessive shots recorded on two (2) targets adjacent and all shot values are 9 and higher, the competitor may take the lowest value shot for record or shoot an alibi string and take the lowest value of that string.</i></p> <p>Competitors/Scorekeepers will not make changes to the Shotmarker scores without match official approval.</p> <p>Issued Paper Score Cards will be the official score for record.</p>

COURSE OF FIRE

Saturday Sep 20 (800 points)

Match 1	2 sighting shots and 20 record – Standing slow fire, 200 yds,
Match 2	2 sighting shots and 20 record – Sitting or kneeling, rapid fire, 200 yds
Match 3	2 sighting shots and 20 record – Prone rapid fire, 300 yds
Match 4	2 sighting shots and 20 record – Prone slow fire, 500 yds

Sunday Sep 21 (500 points)

Match 6	2 sighting shots and 10 record – Standing slow fire, 200 yds
Match 7	2 sighting shots and 10 record – Sitting or kneeling, rapid fire, 200 yds
Match 8	2 sighting shots and 10 record – Prone rapid fire, 300 yds
Match 9	2 sighting shots and 20 record – Prone slow fire, 500 yds

AWARDS

Individual Awards:

The match winner (M11) will be the TSRA High Power Rifle Champion.
Note: Do not have to be a Texas resident to win.

Match 5	Aggregate of matches 1 thru 4 (Day 1)
Match 10	Aggregate of matches 6 thru 9 (Day 2)
Match 11	Grand Aggregate, Matches 5 & 10 – TSRA Champion
Match 12	Slow fire 200yd aggregate Matches 1 & 6
Match 13	Rapid fire 200 yd aggregate Matches 2 & 7
Match 14	Rapid fire 300 yd aggregate Matches 3 & 8
Match 15	Slow fire 500yd aggregate Matches 4 & 9
Match 16	“Back Half State Champion, aggregate of Matches 14 & 15
Match 17	Rapid Fire aggregate Match 13 & 14

1st, 2nd and 3rd Overall will be awarded for Matches 5, 10 & 11
Overall awards will be awarded for Matches 16 & 17

Classification awards

Will be given for placing in each category (Match Rifle and Service Rifle) and class. There must be 5 or more entries in a class/category to establish a class/category. If there are fewer than 5 entries in a category (Service Rifle/Match Rifle) they will be combined with another category in the same class. If there are still fewer than 5 entries after combining both categories in a class, there will be no category awards in that class. All competitors will be moved back to their respective categories and combined with the next higher class, until a minimum of 5 competitors is achieved in the combined class.

Each Classification (or combined Classification) will be awarded a maximum of 3 awards for Match 5, 10 and 11.

Matches 12 – 15 will award 1st in Class only.

Special awards:

High Grand Senior (70 and above), High Senior (60 - 69), High Junior (under 21), High Woman and M1 Garand will be recognized only if there are five (5) or more in that category. Winners will be given the option of a monetary award or a plaque.

Match winners are not eligible for special awards. No competitor will receive more than one award for any individual match or aggregate.

Any competitor who fires a "X" on the first sighter in M1 or M6 will be presented with a "Cold Bore X" award

Highest "X" Count Awards (2 total) to be given to high Adult and Junior with highest X counts
