

# DOMESTIC VIOLENCE AWARENESS and PREVENTION: Gloria Medina

Prevent online sexual exploitation of children. The Eliminating Abusive and Rampant Neglect of Interactive Technologies Act (EARN IT Act) is bipartisan legislation unanimously approved by the Senate Judiciary Committee and is now pending before the Senate. The EARN IT Act is supported by more than 70

groups, survivors and stakeholders, including the National Center for Missing & Exploited Children (NCMEC), Rights4Girls, and the National Center on Sexual Exploitation. CA Senator Dianne Feinstein is one of the original cosponsors of S.3398 – EARN IT Act of 2020.Take Action: Log onto the GFWC Legislative Action Center to send a letter to Senator Kamala Harris

asking her to support the EARN IT Act or contact her office directly.

Members can also send a postcard to Senator Dianne Feinstein letting her know that you support the EARN IT Act of 2020.

On Memorial Day, May 25<sup>th</sup>, my husband Ed and I went to the City of Downey Cemetery to place small American flags on Veterans graves. The Downey Cemetery District traces its roots back in 1868.

We had purchased approximately 100 flags but as we went through the Cemetery we found around 300 to 350 were needed. These graves represent soldiers who fought in the Civil War. From the Civil War there are Union and Confederate soldiers buried together.

In historical research a great many people from the South migrated to California to escape the terrible destruction brought down on the South. It is good that we honor those who fought at Gettysburg, San Juan Hill, Bella Woods, Normandy, Vietnam and a hundred battlefields around the world.

This year marks the 100 Years Anniversary of the ratification of the 19th amendment to our Constitution that gave the American women the right to vote, August 18, 1920.


This is an election year, so be sure to go out and vote for your candidate. The future of our country is at stake.

# **ENVIRONMENTAL**

## Save the Honeybees!

- One of CFWC President, Pam Ament's Special Projects is saving
- the honeybees. How can we as home gardeners support and
- rejuvenate the bee populations in our neighborhoods? Dr. Gordon Frankie of the University of
- California, Berkeley has been studying bee habitats and his recommendations are:
- Eliminate the use of pesticides
- Plant a diversity of nectar- and pollen-rich plants (10 or more species)
- Mass each plant in patches 1 square meter of larger
- Choose plants that bloom in succession over the seasons
- Avoid excessive manicuring
- Set aside some bare patches of soil for nesting

The UC Davis Arboretum and Public Garden put out a PDF introduction to California's native bee population (not necessarily all honeybees but pollinators nonetheless) along with a list of pollinator-supporting plants. The *10 Bees and 10 Plants They Love* brochure can be downloaded here:

If you decide to add one of these plants to your garden to help support California's native bee

population, please be sure to record your efforts. Imagine how many bees we can support in our

communities, if each of us planted flowers to help fuel their flight.

# **LEGISLATION** and **PUBLIC POLICY**

H.R. 1923, the Women's History and Nineteenth Amendment Centennial Quarter Dollar Coin Program Act has gone through a series of negotiations and changes and now has the support of the US Treasury and Mint. Over the past year, since the bill was

introduced by Congresswoman Barbara Lee, there has been much work with the House Financial Services Committee, the Senate, the US Mint, and Treasury to clear the way for enactment. Updated language that accommodates requests

from all stakeholders has been added, which should allow the bill, The Circulating Collectible Coin Redesign Act of 2020, to be considered on the House floor. Currently there are 166 Cosponsors signed onto the bill; 27 of them are from California.

When considering where an art project is reported at the state level, the "intent" of a project

- should be the primary factor in determining where it is reported and detailed in a GFWC Award Entry.
- Here is an example of attributing a project by its intent:
  - An art therapy project that emphasizes the therapeutic value of art: Arts and Culture
  - An art therapy project to aid Veterans with PTSD: Civic Engagement and Outreach
  - An animal-themed art therapy fundraiser to benefit endangered animals: Environment
  - An art therapy project that helps special needs children focus attention: Education and Libraries
  - An art therapy project to aid those with addiction or depression: Health and Wellness



# Susan B. Anthony

Susan Brownell Anthony was born February 15, 1820 in Adams, Massachusetts and died March 13, 1906 in Rochester, New York. She was the first true advocate for woman suffrage in the United States. Susan was a pioneer and activist for the women's movement and was president of the National Woman Suffrage Association (1892 -1900). In her early life she was brought up in a Quaker tradition which nurtured independence and moral zeal. To say she was intelligent is an understatement as she could read and write at the age of three. Susan attended local school and then her father set up a school for which she attended. She ended up going to a boarding school close to Philadelphia.



Her family were very political and participated in the Revolutionary War. Early in her teenage years Susan B. Anthony distributed anti-slavery pamphlets. She worked for the New York State American Anti-Slavery Society

In 1839 Susan took on a position in a Quaker seminary in New Rochelle, New York. She went to a female academy in upstate New York and taught from 1846 to 1849. The year was 1848 and the 1<sup>st</sup> Women's Rights Convention in the US was held. Anthony was teaching at this time and did not attend. A few years later Anthony met Elizabeth Cady Stanton. In 1852 Anthony started the Woman's New York State Temperance Society and became its first president. She was the most zealous advocate and pursued the cause with tireless effort. Anthony and Stanton clashed over the issues of women's rights. She campaigned for married women's property rights which she succeeded with in 1860. She fought against slavery and tried unsuccessfully to alter the Fourteenth Amendment to allow woman as well as African American suffrage. She was ridiculed for her efforts but never stopped pushing women's rights.

Anthony and Stanton published a new periodical called "The Revolution". Later in 1869 both ladies formed the National Woman Suffrage Association (NWSA). People fell away from her fiery demeanor and formed a new conservative group called The Woman Suffrage Association. In 1872 Anthony tested the Fourteenth Amendment by voting in the presidential election. She was arrested, convicted and fined which she refused to pay. Nothing more happened to her on this matter. Anthony fought in California, Michigan and Colorado for women's rights.

Later on in her life she was well received, respected and emerged as a heroine. In 1900 she retired as president of The National American Woman Suffrage Association. In 1906 Susan B Anthony died. It would be another 14 years, after her death, before the Nineteenth Amendment would be passed.

Susan B. Anthony did not care about what people thought of her. She stayed on track and sometimes even her associates would be cringing on how far she would push her efforts for women's rights. She fought long and hard and she lit the fire which would eventually give the right for women to vote. She was a pioneer.
