- We are approaching the halfway mark for this board, and we hope to handoff to a new board in 2026.

- A friendly reminder that we are equal stakeholders in our community, and it takes everyone's efforts

Treasurer report:

- Beginning Balance for May, \$42,462.28.
- 146 residents have paid 2025 dues.
- Tracking 14 homeowners that have not paid 2025 dues, which is 6.875%. 6 of those 14 have not paid 2024's dues. Two of those have not paid 2023. One suit was filed by attorney, and one is in collections by the attorney.
- HOA Fees are due each year. Please communicate with us early and often if you need more time. We will pursue fees through the lawyer otherwise.
- Closing balance of \$43,487.64. A breakdown of incurred costs is on the webpage.

Architectural Control Committee:

- A pool house was approved, as well as driveway extension.

Old Business:

Status of the initial round of letters is unknown since our treasurer is on vacation.

New Business:

- A second round of CCR violation letters were sent the week of June 11.
 - The big issues are unobscured garbage bins, fences in need of repair, garden are dressing (mulch, rocks), grass in flower beds, and weeds in garden areas/yards.
 - Fences that have broken boards need to be replaced and faded stain needs to be refreshed.
- Picnic tables were voted on and approved. Black was the preferred color. We will proceed with ordering.

• Jason Thomas said there is a water line on the property and was supposed to be added before. Travis and Krista will look at getting a water spigot added to the site.
