Mrs. Cindy Biggs

Long-time MRW member and co-founder of Constitution in the Classroom, Cindy Biggs is a dynamic and engaging presenter on America's founding principles. She is also known for her portrayal of Caesar Rodney, the Delaware patriot whose dramatic midnight ride secured a vote for independence. Married for 44 years to Congressman Andy Biggs, Cindy is also an elected board member of the Gilbert County Island Fire District and plays trumpet in the Mesa City Band.



Senator J.D. Mesnard Arizona Senate - District 13

Currently serving his third term in the Arizona Senate representing District 13, Senator Mesnard previously spent eight years in the State House, including two as Speaker. In addition to his legislative service, he has taught political science for nearly two decades at ASU and Maricopa Community Colleges. A husband, father of three, and community leader, he brings deep knowledge of both policymaking and constitutional principles.



County Attorney Brad Miller Pinal County Attorney

Elected Pinal County Attorney in 2024, Brad Miller is a Marine Corps Reserve officer and seasoned prosecutor. He previously spent nearly a decade in the Maricopa County Attorney's Special Victims Unit, earning multiple lifetime convictions against dangerous offenders. He has also built a respected private practice and received recognition for top defense verdicts and veteran

advocacy. His dual legal and military careers uniquely position him to address constitutional protections in Arizona.

Honorable Barbara Blewster
Former Arizona State Representative

A former Arizona State Representative (1999–2001), Barbara Blewster has remained active in Mesa politics and civic education. Alongside her husband Bill, she has hosted countless events to teach and inspire others about the U.S. and Arizona Constitutions. Known for her humor and deep knowledge, she brings “fun facts” and historical nuggets that make constitutional learning both enjoyable and memorable.

RECENT EVENTS



DC Crime Plummets Following President Trump's National Guard Deployment

Washington, D.C. is experiencing a remarkable turnaround in public safety — and it happened fast. Just one week after President Trump deployed the National Guard to stand shoulder-to-shoulder with local police, crime in the nation's capital has dropped sharply across nearly every major category.

The results speak for themselves:

(**NOTE** comparison to the week before NG was deployed and crime rates the same time the previous month)

Homicides: ↓ 29–35%

Sexual Assaults: ↓ 42–46%

Robberies: ↓ 29–40%

Assaults with a Dangerous Weapon: ↓ 15–20%

Burglaries: ↓ 19–22%

Total Violent Crime: ↓ 27–30%

Property Crime: ↓ 6–9%

Overall Crime: ↓ 12–15%

These dramatic numbers reflect not just a temporary dip, but the powerful impact of decisive leadership and a clear commitment to law and order.

Republican Leadership = Real Results

Thanks to more than 800 National Guard troops joining forces with local law enforcement, Washingtonians are beginning to feel safer walking their streets, heading to work, and enjoying their neighborhoods. This is more than statistics — it's peace of mind returning to families and communities.

President Trump's swift action has delivered what so many residents have been asking for: security, accountability, and order. These early results are proof that Republican leadership prioritizes the safety of citizens and is unafraid to act boldly to protect them.

D.C. has turned the corner. With order restored and momentum building, this success story sends a clear message nationwide: **conservative law-and-order policies work — and they work immediately.**

CALLS TO ACTION

● Attention SRP Property Owners in Mesa ●



If you or someone in your household **owns property in Mesa**, you are eligible to vote in the **critical Salt River Project (SRP) elections** happening **April 7, 2026**—but **you must register in advance** to receive your early ballot.

- ⚠ **This is a critical local election for conservatives in 2026.**
- **46 seats are up for grabs**, including board and council positions that control energy rates, water access, infrastructure projects, and long-term power planning.
- **Only landowners can vote**, and with voter turnout historically under 2%, just a handful of votes can swing entire districts.

Why it matters to conservatives:

SRP is one of the last major utilities **not fully captured by extreme green energy mandates**. If we lose control of the board, we risk following in the footsteps of APS—where progressive leadership has pushed costly “green new scam” policies, triggering **significant rate hikes** for families and small businesses. SRP is already under pressure from climate activists. **We must hold the line.**

Mid 2025 – Early ballot registration window opens (registration required)

October 2025 – Candidate forum & official list released
April 7, 2026 – Election Day
