East Bay MUD's Supervising Fisheries and Wildlife Biologist to speak at the February General Membership Meeting

• February is the club's conservation month

It has been over 30 years since the Delta Fly Fishers, in conjunction with the California Sportfishing Protection Alliance, sued the East Bay Municipal Utility District regarding the collapse of the Chinook salmon and steelhead fisheries on the lower Mokelumne. Since that time, EBMUD has not only met all of the requirements of the Joint Settlement Agreement but has gone well beyond what was required of them. Through their efforts, the returning salmon counts have gone from fewer than 50 to over16,000 in some years. They currently have three fisheries biologists on their staff and fund the costs of the Camanche Hatchery as mitigation for the use of the bountiful pristine Mokelumne river water.

At this month's meeting, Michelle Workman, the Supervising Fisheries and Wildlife Biologist for the district will speak regarding the current health of the Mokelumne and the other rivers in the southern Sierra watershed.

Michelle manages a staff of nine and coordinates the long term fisheries monitoring programs, fisheries research, and habitat restoration projects in the Mokelumne River and watershed. She has 17 years of experience with EBMUD. and 5 years of experience with the US Fish and Wildlife Service working on salmonid management and restoration projects on the Tuolumne River, Merced River and the San Joaquin River Restoration Program. She received her Bachelor of Science in 1991 and Master of Science in 1999 in Biological Sciences with a concentration in Biological Conservation from California State University, Sacramento.

While not a "fishing" program, we all need to be watchdogs regarding the health of streams, rivers and lakes. This program will provide us with the information necessary to be good stewards of our water resources.

The meeting will be held at the John R.. Williams School, Don Avenue, Stockton on February 10th at 7:30. Members are encouraged to bring a friend and the general public is invited as well.



In last month's conservation article, it was pointed out that 2016 is

going to be a critical year in stopping the Twin Tunnels Project. One area that is critical in accomplishing this is to curtail the State Water Board's

(SWB) efforts to move forward with their illegal attempts to hurry the permitting process through various agencies. On Tuesday, January 19th, Restore the Delta (RTD) asked the Delta Fly Fishers to state our position against what the SWB is trying to do. The meeting was held in Sacramento at the CalEPA building. Organizations with interest in

the SWB actions were given 3 minutes to present their arguments. When it was my turn I spoke about the catastrophic losses to our fisheries in the Delta due to their contining malfeasance of their duties regarding water exports. I reminded them that in California there are stringent requirements to be granted licenses to practice medicine or dentistry. A major requirement is a practitioner must take post grad education to stay current with their field. If they do not, the State con-

siders them "unfit to practice" and

removes their license. The SWB is

required by law to update the Wa-

ter Quality Control Plan (WQCP) every 3 years. However, the SWB has not done so in over 20 years and are in violation of both the federal and state Clean Water Acts. Since they are acting illegally in fulfilling their required obligations, they should not be allowed to sit on the SWB. There was no response.

It's not *just* fish that are in danger.

A week after the SWB meeting, Restore the Delta (RTD) held a teleconference regarding the

SWB actions and the ongoing problems of the Delta's decline. The SWB's action's will destroy the only source of drinking water for one million people and cause many other catastrophic problems in the Delta. The SWB seems to see the Delta as "California's sacrifice zone." The major theme of the

> teleconference was. "How did we get into this situation and what must be done to fix it now?"

Bob Wright, attorney for Friends of the River, pointed out that the Environmental Protection Agency (EPA) trashed the Bay Delta Conservation Plan (BDCP). Gov. Brown came up with the California Water Fix (CWF). The CWF is

just another plan to export water around the Delta with no environ-

mental protection. This would prevent the fresh water flowing through the Delta as it has for thousands of years. No other options have been mentioned. There is no "Plan B". Wright used the analogy of a patient bleeding to death in an emergency room and taking his blood for a blood drive. He commented, "The Delta needs more freshwater, not less freshwater. The Delta Tunnels are dangerous weapons aimed at the people living in the Delta." The BDCP/Water Fix plans intentionally exclude fresh water to the Delta and exports that water to corporate agriculture and the Metropolitan Water District of Southern California (MWDSC). There are viable plans, such as the Environmental Water Caucus' (EWC) plan, that "would reduce exports and is focused on 21st century water solutions such as urban and agricultural water conservation, recycling, store water recapture and reuse, and rein-

The health of the Delta directly effects the health of the San Francisco Bay, its' fish and crab industries, the Bay's environment, and its' economy. Friends of the San Francisco Estuary, Darcie Luce, noted that the Bay's fresh water quality has been declining and we are "doing a worse job in the past decade. What is evident is the widespread decline in our fish species. She quoted Dr. Peter Moyle, an outstanding authority on our fisheries saying, "That from a fish prospective, California has been in an increasingly severe drought since the 1960's; and that in this current extreme drought, the environment is the 'water user' that has suffered the most". Luce spoke

about how the recent toxic algae blooms are an indication the decline of fresh water has had on the San Francisco Bay.

RTD's Tim Stroshane, Policy Analysist, and Barbara Barrigan-Parrilla, Executive Director, both contributed to the teleconference. Tim spoke on the Delta's continuing lack of a federal and state required Water Quality Control Plan (WQCP). Both the state and federal law require that the WQCP be

which they did. But the SWB has did nothing and totally ignored what their studies found. For 20 years they have failed their duties as required by law. Stroshane pointed out that despite a current WQCP, the Twin Tunnels Plan asked the SWB for water rights to build and operate the Twin Tunnels despite the fact there is no water plan saying those tunnels should be built. Stroshane pointed out that builders do not build a house first, then determine if their



completed every 3 years. For 15 years, between 1980 and 1995, the Delta did not get a WQCP. Since the state had not acted, the US Environmental Protection Agency (EPA) issued it's own Delta regulations in 1993 that are still in place. However, in 1995 our fish populations fell drastically and many species were placed on the both Endangered Species Acts and listed as threatened or endangered. In 2005 the collapse of the fisheries intensified. But water exports increased by 50% to 3.6 million acre feet in 2000. Still the SWB did nothing. In 2009 the legislature ordered the SWB to find how much water the fish required,

pluming is going to work. That is done before construction, not after the fact. But the SWB wants to devise a WQCP and grant water rights at the same time. And there will be extreme political pressure on the SWB to do just that.

Barbara Barrigan-Parrilla spoke to the political and administrative nature of the SWB and how that effects their decisions. The SWB is appointed by the Governor and he notes their performance. The bottom line is that if they do not follow his

agenda, they will be replaced. This its true for all state agencies. This fact alone guarantees their actions will be make politically, under pressure, and not in compliance with our laws and the best science available. Tim Stroshane pointed that out in his presentation. The SWB should not consider a water rights permit until after we have a WOCP in place and then follow that plan to determine if the Twin Tunnels should be built. As Barrigan-Parrilla points out, the SWB is under a huge amount of pressure and seeking to have 2 permits granted simultaneously without knowing how much water is available. It's a recipe for disaster. She also pointed out the pressure the SWB is under. The MWDLA has already spent \$100 million trying to push the twin tunnels down our throats. This money is from their rate payers. The water districts feel they will get an increase in their water supply from the tunnels. This will, of course, occur at the expense of the water that should be flowing through the Delta. The pressure on the SWB comes from Gov. Brown, MWDSC, Westlands, Kern County Water Agency, corporate agriculture, and Californian's for Water Security. In addition to the pressure they are putting on the SWB, they are planning to discredit accuracy of the Delta's history as an estuary of fresh water. They plan to put forward their own "history" so the SWB will not adopt standards for increasing fresh water for the Delta. The major point that Barbara made in her presentation was in the form of a question. "The question will be if they (SWB) have the moral courage and the fortitude stand up to

Gov. Brown's political push and the rewriting of state water history by the Metropolitan Water District".

California Sportfishing Protective Alliance's (CSPA) Bill Jennings (Chairman/Executive Director) spoke to the devastation occurring to our fisheries in the Delta. He started his presentation by reminding us that our fisheries "evolved and prospered over thousands of years and survived the 100-year mega droughts of the past". He noted that Fish and Wildlife 2015 Fall Midwater Trawl has shown that the 6 species studied are at their lowest levels since the populations were first counted in 1967. The average loss of fish population in the Delta was 97.9%. The Anadromous Fisheries Program, started in 1967 also, has shown that the natural production of Winter-run and Spring-run Chinook salmon in the Sacramento River has dropped 98.2% and 99.3 % respectively. Bill pointed out that the outrageous loss of our fish was not caused by nature by rather by federal and state regulatory agencies who are controlled by politically powerful special interests. He commented that the Dept. of Water Resources (DWR) and the US Bureau of Reclamation (USBR) have only complied with water quality standards 8 of 21 years. Even though there have been "thousands upon thousands of violations", the SWB has never enforced legal action and the fishery agencies have always gone along with this action and said nothing. These actions continued with the SWB in 2014 with the reduction of the required Delta flow by 43%. However, they increased the exports by 18%. In 2015, Delta flows were reduced by 78% and exports were increased by 32%. This amounted to over 1 million acre-feet of water that would have protected our fish and the Delta's environment being used for corporate agriculture. Bill Jennings also noted that in each of the drought years, "Central Valley agriculture production has set new record highs".

The longer one is around groups trying to protect the Delta and the more accurate information we get about how our state and federal agencies bow to the special interests at the public's expense, the more angry you become. This is especially true with the Delta and our fisheries. Jennings summed it well regarding our fisheries by saying, "Our captive regulatory agencies are sending our fisheries to the scaffold because the demands of special interests outweigh the protection of public trust resources belonging to all Californians". More people are needed to stop these illegal activities of the SWB.
