For those members who are interested this event and have not completed their registration steps, I would not wait much longer to sign up and pay the \$10 event fee. Eleven of the 18 available spaces have been filled already and with the drought conditions these waters are one of the best locations for local tail-water fishing.

If you have attended before, the essential information of this year's trip is the same. For those members who haven't attend before, we will meet at the entrance gate at 7861 Scott Forbes Rd, Browns Valley, CA at 7:00 am sharp on January 30th. This property is owned by the UCD Foothill Research Center. The directions are straightforward and there will be signs to point you to entrance of the property. I will be send-

ing detailed directions, a map, and suggested gear to those would be signed up.

Each angler will need to be pre-registered with the UCD office, have a valid CA fishing license with a steelhead report card (filled out for that day) and a 2016 DFF liability waver form on file with Karen Keagy. Our big hot lunch will be provided between 12:30 – 1:30 pm probably bacon cheeseburgers or grilled chicken sandwiches and all of the side dressings.

Conservation: 2016, another year of the "Water Wars" lie in front of us. And yes, we need to step up.

Fly fishing is not an escape from life, but often a greater immersion into it.

Last year was a year of devastation for our fisheries. Four years of catastrophic drought and the mismanagement of our water by the Bureau of Reclamation (BOR), the Department of Water Resources (DWR), and the State Water Resources Control Board (SWRCB) have pushed much of our state's salmon population near extinction. I hope that with a potentially wet El Nino in 2016, nature may give us a hand with the drought. Unfortunately, the SWRCB, the BOR and the DWR will not. Last April, Westlands Water District (WWD) trucked three busloads of farm laborers to the April meeting of the SWRCB. This group, with the help of translators, begged the SWRCB for water for "health, and human safety." Denying requests from environmental groups to identify how that water was to be used, the SWRCB granted over 250,000 acre feet of water for Westlands's farm workers. Despite repeated requests, neither WWD nor its farm workers have responded to questions as to who received the water for health and human safety. However, Para-

mount Farms planted over new 2,000 acres of new almond orchards and this year, plans to plant 4,000 acres more. All of this was occurring while the BOR and DWR claimed there was not enough water to release into the Lower Sacramento River to maintain legally required temperature standards for the salmon. As a result, we lost 95% of last year's salmon run.

This year will be pivotal in our fight to stop Gov. Brown's Twin Tunnels Water Fix and save the Delta. Just before Christmas, I got a call from Barbara Barrigan-Parrilla of Restore the Delta (RTD) asking Delta Fly Fishers to attend a meeting with over 40 different organizations opposing the Twin Tunnels. This group included cities and counties, business groups, fishing groups, elected officials, recreational users of the Delta, and farmers. Barrigan-Parrilla outlined the three issues we need focus on this year:

One) The SWRC will attempt to push through federal permitting in spite of the fact they have not completed any of the required environmental studies nor met the legal standards issues that are required. RTD and other groups will be working to ensure that the required standards and environ-

mental issues are enforced. This will require media attention and litigation.

Two) HR2898. This bill will proceed to the next session of the congress. At this point, members of the Republican Party are working with Sen. Feinstein behind closed doors to rewrite sections of HR2898. As written, the bill will wipe out our fisheries and doom the Delta. We need to watch HR2898 closely.

Three) State Water Resources Control Board. This is the area where we need the most help from community leaders and their groups. In the past I have attended the SWRCB meetings where our fisheries have been concerned. I want to thank our members, Jerry Neuburger and Norm Walker, who have stepped forward to help make presentations to the SWRCB and represent the Delta Fly Fishers at SWRCB board meetings.

There are two major permitting issues the SWRCB is trying to push through this year. One is the point of diversion (intake) for the tunnels. To do this they must prove there will be no harm to the Delta or users of the Delta. This promises to be a major battle. The second major issue the RTD will fight is the SWRCBs non-

Read Carefully - Affects Your Legal Rights **FOR THE YEAR 2016** RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK HOLD HARMLESS AGREEMENT AND INDEMNITY

1. In consideration of participating in *Fly Fishing and Activities related thereto* and other valuable consideration, I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE *Delta Fly Fishers*, their Board of Directors, the officers, chairpersons, agents and members (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions on causes of action whatsoever arising out of or related to any loss, damage or injury, including death, that may be sustained by me or to any property belonging to me, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in any such activities or while in, or upon the premises or location where such activities are being conducted or in transportation to and from said premises or location. *This agreement shall be effective for all activities during the calendar year in which this agreement is signed.*

2. To the best of my knowledge, I can fully participate in these activities. I am fully aware of the risks and hazards connected with the activity including but not limited to the risks of drowning, hook injury and as noted herein, and I hereby elect to voluntarily participate in said activities and to enter the premises and locations where the activities are being conducted, knowing that the activities may be hazardous to me and my property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, or any loss or damage to property owned by me, as a result of being engaged in any such activities, WHETHER CAUSED BY THE NEGLIGENCE OR DELIBERATE ACT OF RELEASEES or otherwise.

3. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASEES from any loss, liability, damage or costs, including court costs and attorney's fees, that may arise from my participation in said activities, WHETHER CAUSED BY NEGLIGENCE OR DELIBERATE ACT OF RELEASEES or otherwise.

4. I WAIVE the protection afforded by any statute, or law in any jurisdiction (e.g. CA Civil Code 1542) whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing the release.

5. This Release and Hold Harmless Agreement shall bind the members of my family and spouse (if any), if I am alive, and my heirs, assigns and personal representative, if I am not alive shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the above named RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of California.

6. I FURTHER UNDERSTAND THAT *Delta Fly Fishers* or any of the named Releases will not be responsible for any medical costs associated with any injury I may sustain. I also understand that I should possess adequate health and accident insurance to cover any personal injury to myself which may be sustained during the activity or transportation to and from said activity.

7. I further agree that I am or will become familiar with the nature and requirements of said activities before participating. I further assume the complete risk of any activities and I will provide any and all safety equipment, whether or not required by law. IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT, I have read the foregoing Waiver of Liability and Hold Harmless Agreement, and understand if I sign it voluntarily as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.

compliance with California's Water Quality Plan (WQP). The board will try to continue to lower water standards for the Delta. This will continue to hurt our fisheries and hurt drinking water standards throughout the Delta. The SWRCB is required by law to update the Water Quality every three years. They have not updated the plan as required in the last 24 plus years! This year they will continue to try to lower the Delta's water

quality once again. Again, I want to thank both Jerry and Norm for stepping forward to help. I have worked with Jerry and have known Norm for many years. They will be a great asset in representing our club before the water board.

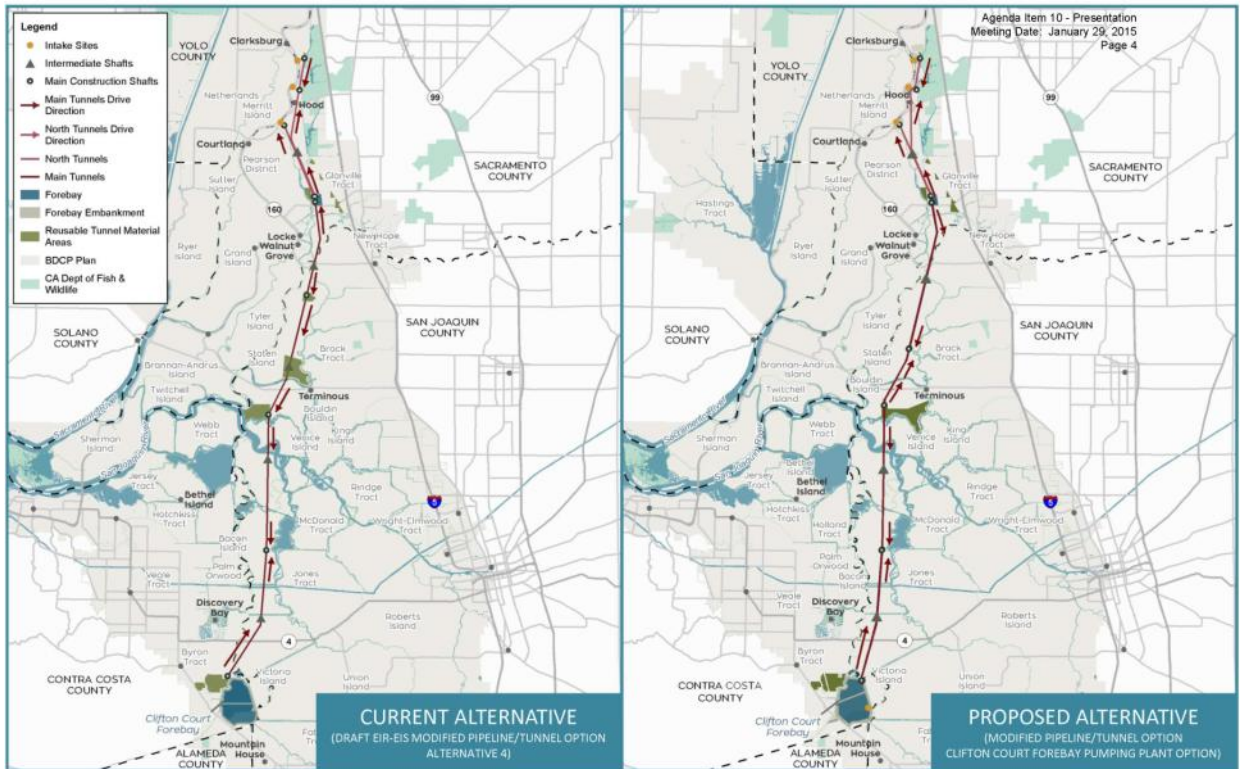
Barbara spoke to

me privately of her concerns of not receiving help from recreational fishing clubs in the Delta in protecting the fisheries. Delta Fly fishers is the only club that has stepped forward to assist RTD. The Northern California Council of International Federation of Fly Fishers, Trout Unlimited, and Cal Trout talk a lot about environmental concerns of our fish but have done nothing to prevent the greatest potential disaster ever to face the state's fisheries. Barbara has asked me to involve local fly

fishing and striped clubs to step up to the plate. I have contacted the conservation chairs of California Fly Fishers United (CFFU), Keith Pfeiffer, and conservation chair of Davis Fly Fishers, Lowell Ashbaugh to help, and their response has been positive. This month I plan to contact other clubs to get the ball rolling. Anyone interested in helping with this project, please call me at 209 368 5767. Thanks.

Barbara has recognized them as "the most prolific and effective citizens organization enforcing the Clean Water Act in the nation." Without their actions giving both technical and legal comments to agencies on their policies and their litigation against actions, our fish would be in worse condition than they are.

In CSPA's website, Bill makes the point that 2016 is going to be a "pivotal year that will see some



California Sportfishing Protective Alliance (CSPA)

The only major fishing group fighting to protect the State of California's fisheries is the CSPA. I first met Bill Jennings, CSPA's Executive Officer, the night RTD formed in 2007. Since I have known Bill and worked with him and his board, I have been astounded at what they have been able to accomplish with little support. The U.S. Department of Jus-

key decisions made about the future of the Delta and California's salmon, striped bass, and other key fisheries. These decisions on the future of the Delta will irrevocably and forever impact the fisheries from the Sierra's crest to the Golden Gate. Make no mistake, if the Governor and Southern California water agencies schemes to divest water via tunnels under the Delta are successful, the fate the estuary, its tributary rivers and

abundant fisheries are likely sealed". CSPA's workload will be overwhelming in 2016.

Check out the CSPA's website and look at the new California Fisheries blog. The blog makes fisheries issues easier to understand. An-

other point CSPA makes is how effective they have been fighting the polluters and protecting our rivers, stream, and lakes. Over the last few years they have brought legal action against over 100 polluters and collected \$5.9 million. CSPA cannot, by law, benefit directly or indirectly from their actions. The money was distributed
