Okay, it's back to work as normal now that the Olympics are over. What a fantastic show. Oh, well, enough of the Olympics.

I would like to alert any of you members traveling out to Oak Grove Park on off-meeting nights, on Wednesdays, there soon will be a change regarding our parking status. The Parks Department of the County is initiating a new policy for parked cars after hours when the park closes to the public; they want us to display a parking permit in our windows on the driver's side while parked and either casting or inside the Nature Center tying flies. We are in the process of providing a list of up-to-date members so the county can print parking permits for each of us. Any car not displaying a parking permit when the county sheriff comes around will get ticketed. Presently Jim Rich and Rick Greene are providing temporary parking permits to those of you who come out to the park. Once the county gets the proper number of permits printed, we will have to replace our temporary ones with the county's permit.

Unfortunately any guest non-member who comes out to participate in our casting instruction or learn fly tying on Wednesdays will have to pay the usual parking fee. If there is no one at the check-in booth when you come out, there are envelopes to deposit your money into and deposit it in a box. The same applies to anyone who volunteers to work the Catfish derby or Trout Bouts. The parking fees are \$3.00 weekdays and \$5.00 weekends.

We're now heading into the home stretch for the Festival of Fly Fishing to be held this year at Hutchins Street Square,Lodi. I've been getting several questions from you members wanting to know how the planning stages are coming along. There will also be vendors there so you can see the latest equipment you may want to purchase. First of all, our committee chairs are as follows: Programs, Steve Cooper; Registration, Jerry Neuburger; Raffle/Silent Auction, Dan McDaniel; Publicity, Doug Ridgway; Exhibitor/vendors, Charlie Edwards; Fly tying theater is Dave Kruss from the Federation; Casting clinics is Eric Sherar, also of the Federation, and finally myself and Dustin Rocksvold of the Amador Fly Fishers are co-chairs overseeing the event. There will be several affiliated fly clubs with booths to advertise their club activities and tempt the public to join same such as our club – Bob Souza is the member in charge of our booth – Tracy Fly Fishers, the newly formed Stanislaus Fly Club from Modesto and, of course, NCCFFF and Cal Trout among others.

To date we have set up an interesting group of speakers to entice you to sit down and listen to their ways of fishing different waters, including advanced pontoon boat techniques, Delta largemouth bass, how to visualize your cast, techniques for Northern California steelhead, of course fly fishing the Delta with our featured speaker Dan Blanton as well as Jerry Neuburger, warm water fishing opportunities, even sail fishing Guatemala and of course our own Leo Gutterres on top water bass as well as Al Smatsky on salt water destinations. Guy Manning will give a talk on breaking the fish, not the rod. Other than those speakers heretofore mentioned there will be Steve Cooper, Michael T. Williams, Dave Scadden, Ray Hutcherson, Jay Murakoshi, Andy Guibord, Frank Pisciotta, Jim Roberts and Ralph Wood. In the casting category we'll have Mel Krieger talking and demonstrating the essentials of fly casting, Floyd Dean improving & perfecting your double haul. For a \$20 fee you will get some individual casting instruction in a class of no more than 10 from Al Kyte and John Till. This will be an opportunity for you new members – and veterans alike – to find out from the best instructors how to go about perfecting your casting. I realize most of you newer members are not familiar with the fly fishing folks I've listed above, but this will be a great opportunity for you to come out and see what it's all about, and, it's in our own back yard.

At our September meeting, we'll be passing around a paper for any of you members to sign up as a volunteer so we'll have a head count to know how many others we need to get involved from the other local clubs. Our O ctober potluck is the Wednesday before the festival so we'll have a question-and-answer period to let you know what's involved. Of course there will be a Friday chili feed and a Saturday sit-down dinner with auction.

Eastern Sierra Focus

Fishing Tip:

Terrestrials and midges have been the hot surface flies for the past couple weeks along with nymphs and streamers. Although terrestrials are not a mainstay item in a trout's diet, they do play a significant part in their behavior. One of the reasons that large trout cruise the inlets and shorelines is to feed undisturbed while getting a change in diet from bugs that enter the lake through wind-drift or just fall from the trees and bushes overhead or nearby. These morsels seem to excite large trout into showing a little "dorsal". Try fishing parallel with inlets where overhanging pine trees, shrub willows or brush that would protect any type of these tasty morsels when the wind is in your favor.

Used an emerger late last evening and had the pleasure of seeing a pig-of-a-brown take a bat off the surface of the lake just as it was dipping into the surface. It was quite a sight to see such surface disturbance, and he did it twice Incredible! Just when you think you have your evening fly patterns down, this jumbo brute makes a horses-pituti out of you. Must be some bat patterns out there.

Weather

The Eastern Sierra has returned to normal for August, the heat is on and lower elevations are suffering from above the "hundred" mark. Last year this time we had received our first snowstorm of the season, but that is not likely to happen this year.

Legislation

Dave Cogdill's AB7 was reinvented with SB1262 to give DFG some latitude in their production time and with their species breeding. It's a bit difficult, without a law degree, to actually determine what this all means. We have not seen much of an increase in the stocking even though the region was to get 250# per lake throughout the stocking season. I've printed the original bill and printed SB1262 and without a copy of the DFG Code it is hard to determine just exactly what the changes on page 2 really mean. "Fish produced in mitigation hatcheries shall be excluded from the computation of the 25-percent restoration goal required by this paragraph". According to AB7, "Existing law requires the DFG by 7.1.11 and according to a specified schedule, to ensure that 25% of the fish produced by state fish hatcheries are used for the purpose of initiating and managing the restoration of naturally indigenous stocks of trout to their original California source watershed". So if you can read between the lines, fish have been excluded. Everything that the Department is experiencing in their budget with regard to stocking, mud snails and the logistics has not changed.

News: Recent flooding that occurred the weekend of the 11th of July practically ruined Mt. Whitney hatchery and the 30 plus years of brood stock that had been managing there. No plans in the works to get it up and going again, but there is speculation as to what type trout would handle the conditions.

ROCK CREEK AREA and MOSQUITO FLATS – Are doing well and the mosquitoes are virtually gone for the season. Small to medium dries are working in the upper basin, and streamers and large dries along with some caddis patterns.

UPPER OWENS – Has been the hot spot for stream fishing with a variety of nymphs getting the most action, and dries late afternoon. Flow is down but it's still fishable. I did almost 1 mile in 3 hours and caught about 10 good size bows and two wild browns. A two fly rig is still a great way to get into browns, so try using Micro midges, hare's ear, prince nymphs, and tiger and zebra midges. I'm still a slow set, but working diligently on it, and I hate using a 3X tippet but it doesn't break off. Please remember to wash your equipment as mud snails are everywhere and not going away.

HOT CREEK – Water is at 50cfs and having one of its best years. The trout are demanding your best ability. Flies that have been working in the morning and mid-day are EC caddis, light Cahill's, grasshoppers, pheasant tails, scuds and disco midges. Please stay out of the water to prevent the spread of the New Zealand mud snail and fish during the coolest times of the day to minimize the stress on the trout. I'm need a good recipe for barbequed snails served on a French roll with honey mustard. CROWLEY – Water temperature is near the 70 degree mark except in McGee Bay, crooked creek and the mouth of the Owens, as reported by Kent Rianda of the Trout Fly, and he suggests gray/black #16 Optimidge mornings, then switch to calibaetis. Try stripping just over the weeds, and stay in the weed seam and use an intermediate line.

UPPER OWENS – Is now at 58cfs below East Portal gauging station and minimal water is being diverted from Grant Lake into the Upper "O" so the river is lower than usual for August and is totally fed by the springs and the water that comes in from Hot Creek mid-way down. Midges, trico's and caddis are the mainstay, but Spinners have been doing good mid-morning with good afternoon hatches. Fish are taking everything with a delicate touch so be extra alert.


MAMMOTH BASIN – Good to excellent action found in the basin tugging bugger or minnow patterns with a dropper using a nymph or small midge deep and near weed edges. Try Griffith's gnats, midglings, small baetis #18-22, and callibaetis dry's. SAN JOAQUIN – Is low but and you will have to walk the area for the pools and turnouts where fish are holding. Try some large dries like humpies, stimulators, and Royal Coachman's where you think fish are holding.

RUSH CREEK – Flows are up and down due to the water man at the top of the tracks at the base of Gem Lake. Reports coming from the area are good with lots of fish being taken on large terrestrials (ants, and hoppers)

JUNE LAKE – Is constantly getting their infusion of Cutthroats and doing well with standard streamers in dark patterns near weedy areas of the lake will get hit, the west end and on the northeast shore just west of the "beach". Watch for feeding trout early evening and tug, Wooly Buggers, Doc's Twin Lake Special in Black or Olive and brown Leeches are all doing the job GULL LAKE – Is fishing fair to good but check with Gull Lake marina for the latest stocking and what has been getting grabs. SILVER LAKE - Most of the fish coming out are being taken near the Rush Creek inlet area. Brown and some purple woolly buggers and Rainbow Hornbergs for those Alpers browns. VIRGINIA LAKES – Action had been good late evening with small dries. That brown has my number, and he's giving me indigestion. The plant numbers holding regardless of the distance of the hatchery where the fish are raised. Flies that have been working are Olive Elk hair Caddis, Mosquito, Black Gnat, large Black Ant, Doc's Twin Lake Special in black and olive, and the number one fly is the Grey Hackle Yellow. Some emergers have been working and also RS2s. Last couple nights the EC Caddis Emerger in black did exceptional on 6x fluorocarbon tippet. EAST WALKER - Flow is at 112cfs. The water is way too warm and the fish are sluggish, it is my suggestion not to fish the river until the temperature drops below 70.

BRIDGEPORT RESERVOIR – Is very warm but the fish are active in the middle of the lake. Fish are holding at about 12-15 feet of water and fish near Rocky and Rainbow point. Damsels are the number one bugs of the Rez.

WEST WALKER – Is 43cfs and the best spot would be just past the bridge down to the first campground. Large dries with a small dropper about 18" below, or use 2 small flies. Prince nymph has been good as a bottom fly, but mending is a bit of a challenge.



The map above presents National Marine Fisheries Service (NMFS) designation of steelhead listings throughout California by Evolutionarily Significant Units (ESU's). A brief assessment of the health of steelhead in each of the State's six ESUs is presented below.

Klamath Mountain Province. ESU 7, Status: Listing Not Warranted.

Steelhead in this ESU were originally listed as Candidate status which means that NMFS did not consider them endangered or threatened, but warranted monitoring. A legal judgment required NMFS to re-evaluate their decision and on March 28, 2001 NMFS declared the ESU as Not Warranted for listing. This no-list decision was based on evidence indicating the ESU was at a lower risk of extinction than at the time it was originally proposed for listing. This ESU includes coastal river basins from the Elk River in Oregon to the Klamath River in California. This ESU contains populations of both winter and summer steelhead. The historic range of the steelhead on the North Coast has not been reduced as drastically as it has in other areas of the state and, consequently, is home to the most abundant populations. The Klamath-Trinity river system supports the greatest number of steelhead in California. Steelhead runs in North Coast drainages are comprised mostly of wild fish. Adversely impacting North Coast stocks are logging, agriculture, water diversion, gravel mining, migration barriers and introduction of exotic species.

Northern California. ESU 8, Status: Threatened

This ESU includes California coastal river basins from Redwood Creek south to the Gualala River. The life history of steelhead in the Northern California ESU parallels those of the Klamath Mountains Province ESU. Steelhead within this ESU include winter and summer steelhead, including what is presently considered to be the southernmost population of summer steelhead, in the Middle Fork Eel River. As with the Rogue and Klamath Rivers, some of the larger rivers in this area have year-round migrating steelhead as well as seasonal runs. While there are no recent population estimates for this ESU, the substantial declines in run size at the region's major dams indicate an overall decline in abundance from historical levels.

Central California Coast. ESU 9, Status: Threatened

South-Central California Coast. ESU 10, Status: Threatened

Historically, most streams along the Central Coast had healthy populations of steelhead. Of 122 streams south of San Francisco Bay known to have contained steelhead, 47% have reduced production from historic levels and 33% no longer support populations. Central Coast stocks of steelhead have been impacted heavily by urbanization (particularly in the greater San Francisco Bay Area), agriculture, water diversion, migration barriers and habitat loss. Populations aren't as healthy as northern stocks but less imperiled than southern stocks.

Southern California. ESU 11, Status: Endangered

Southern steelhead were once found in many of Southern California's streams and rivers -- as far south as steelhead populations. Numbers have declined drastically in nearly all streams where they exist, and runs have been wiped out from many others. Urbanization, water impoundment and diversions and man-made migration barriers have all contributed to this decline.

Central Valley. ESU 12, Status: Threatened

Steelhead ranged throughout the tributaries of the Sacramento and San Joaquin rivers prior to the frenzy of dam construction, water development, and watershed perturbation in the 19th and 20th centuries. Populations have been most severely affected by dams blocking access to the headwaters of all major tributaries; consequently, most runs are maintained through artificial production. The decline of naturally-produced steelhead in the Central Valley has been more precipitous than that of the hatchery stocks. Wild stocks are mostly confined to upper Sacramento River tributaries such as Deer, Mill and Antelope Creeks the Santo Domingo River in northern Baja California. Originally, Malibu Creek in Los Angles County was thought by NMFS to be the southern-most stream containing a known spawning population; a recent discovery of steelhead in San Mateo Creek in San Diego County has led NMFS to extend this ESU boundary to that point. South Coast steelhead are the most jeopardized of all of California and the Yuba River. Remnant populations are believed to be rebounding in San Joaquin tributaries such as the Stanislaus, the Tuolumne and the Merced rivers.






