President's Message by Herman Spalinger

If that fish was three inches long before he hit the fly, he ended up being six inches after I set that hook.

For you newer members, who have just joined this club, please feel free to use our buddy program. Bob Souza and Grady Lee are more than happy to get you started in the right direction. Also Jim Rich and Rick Greene are always on hand at Oak Grove Park pond every Wednesday evenings during the late spring and summer from 6:00 p.m. to dark to fine tune your casting stroke or help you get started casting correctly. If you're new to fly fishing and you ask some of our members on what equipment you'll need, you'll probably get as many answers as there are members. I'd suggest Bill Laughlin, our Raffle Chairperson, would be a got start as he deals with a lot of equipment for our raffles, and he might have some great suggestions so you won't have to mortgage the house to pay for some new fly rods or waders. You might be aware of the down side when buying new equipment, though, as you'll probably drive your wife crazy spending money for equipment she might not use.

Again, I'd mention that every Wednesday during the year, except meeting nights, there are usually several club members tying flies at the Nature Center at Oak Grove Park from about 6:00 p.m. to 9:00 p.m. Any one of several members, Bob Souza, Joe Balderston, Dean Watson, Steve Cooper, Jim Rich, or others who happen to show up, will be more than happy to help you get started in tying your own flies.

Another note for you newer members who attend our regular meetings, our Board members and regular members will strive to take the opportunity to introduce themselves to you and help you get acquainted with our club's activities and outings. We sometimes tend to be a little "caught up among ourselves" telling our fishing stories to each other, so don't hesitate to step up and kick a shin if you need to and introduce yourself as a new member so we can all become acquainted. My past experience with this club and its members has been stellar beginning with my first attendance at an outing up to the present time. I still remember Charlie Reames taking the time to meet me at Lake Davis to help me get my new float tube into the water and suggesting some nymphs to use. I actually caught a fish or two that day. As you can tell, one thing I lack, is knowing when to stop writing, and so I will strive to keep these future president's messages shorter. 


Public Barbs Over Delta Pumping Proposal Build Into a Flood of Dissent

TRACY - A fisherman who has trolled the Delta for 40 years. A homeowner concerned about property values. An environmentally aware eighth-grader completing a homework assignment.

Many voices have weighed in on a disputed plan that could send more Delta water to Southern California. And their general disapproval may signal years more debate before anything happens, some observers predict.

"The odds that this damaging project will be litigated are somewhat better than the certainty that Christmas will arrive on the 25th," said Bill Jennings, a longtime Delta environmentalist who heads the California Sportfishing Protection Alliance.

About 18,000 comments - a good portion of them form letters - poured in earlier this year as the federal and state governments continued to study the \$100million plan. Officials' most recent report, released last week, shows they're still considering increasing water exports from pumps near Tracy.

Those pumps are targeted by environmentalists who say they suck up endangered fish and draw in salt from San Francisco Bay, threatening the water supply for two-thirds of Californians.

One Discovery Bay resident told water officials earlier this year that sea lions are frequenting his town.

"It used to be a rare occurrence, and now I find them sleeping on my neighbor's dock," Jerry Creech said. "Farmers are finding salt on their land. This is a result of too much water going south."

While most of the public outcry is over increased pumping, there is much more to the plan. Its first goal, in fact, is to deter salmon from straying into the south Delta, where the pumps send an average 1.9trillion gallons of water south to cities and farms each year - enough water for about 5.9million families.

Four gates would be built to keep the fish away from the pumps and make it easier to deliver water to Delta farms, said Katherine Kelly, who heads the state Department of Water Resources' Bay-Delta Office.

Some channels would be dredged to allow faster flows, thus improving water quality.

A decision whether to increase pumping will come only after these improvements, which themselves have yet to be approved, Kelly said.

A range of scenarios ultimately could increase the pumping anywhere from 3 percent to 5 percent. That doesn't mean any more water would be exported, Kelly said.

"It would, however, give us more flexibility" to use surplus water, she said.

Rep. Dennis Cardoza, D-Merced, has called the plan "responsible" with only modest increases in exports.

The California Department of Fish and Game, however, recommended additional study. A gate at the head of Old River, for example, could keep fish out of the pumps but might not help juvenile salmon heading out to sea avoid a number of other hazards such as poor water quality and low flows.

Byron resident Frank Middleton, who has been fishing the Delta for decades, said the proposed barriers could restrict access to miles of prime fishing grounds.

"I really feel there's a lot of people it may affect directly or indirectly that maybe aren't even aware of it," he said.

Forging ahead with a major project when fish species are dwindling remains Jennings' greatest worry. The decline of the Delta smelt, for example, is an indicator of the overall health of the estuary.

"It's senseless given the present state of the Delta," Jennings said.

Conservation - By Ron Forbes

Two weeks ago I had the pleasure of meeting with Dr. Joe Merz of EBMUD. As many of you know Joe is an aquatic biologist employed by the water district to help in improving the situation on the Mokelumne. Joe is doing an excellent job and I feel together we will be able to contribute with some positive conservation efforts. The reason for the meeting was to discuss ways in which Delta FF might become involved in conservation projects along the Mokelumne River. He suggested several projects including river clean up, possible removal of non native plants and re-establishing the native vegetation which will enhance a better environment for the aquatic life including the fish. After the first of the New Year we will be meeting again. By that time Joe thinks he will have some ideas as to how Delta FF can be of the most help.

On a less friendly note, the new Peripheral Canal bill has been introduced into the state senate. This occurred in the first week in December. The author of the bill is Senator Joe Simitian (D). With this legislation he wants to solve the problems of:

- 1) Drinking water quality
- 2) Drinking water reliability
- 3) Water conveyance

There is no mention of "safety valves" for the environment and there is far less protection for the environment in this bill, than the one defeated some 20 years ago. Again.....no built in protection for the Delta. We need to keep informed on this bill's progress and do what we can to help defeat its passage.

As you may have heard, the Northern California Coastal Wild Heritage Act has been signed into law. Rep. Mike Thompson sponsored the act. This bill will add 21 miles of the Black Butte River and its tributary, Cold Creek to the National and Scenic Rivers system. Both the Black Butte River and Cold Creek are important spawning rivers for both salmon and steelhead. Several years ago I hiked the Lost Coast Trail, on the north coast, and enjoyed its rugged beauty. This act will allow the area to remain wilderness. The trail is 26 miles of some of the most remote coast line in California. This bill adds 275,000 acres of new wilderness for the state including the Lost Coast, and additions to the Siskiyou, Trinity Alps, Snow Mountain and the Yolla Bolly Wilderness areas. Three members of NCCFFF have been given much credit in helping the passing the act. The members are Sandy Leo, Darrell Bridge and Michael Mac Williams. It's felt that Darrell and Sandy's work with former Rep. Pombo helped in keeping him from acting against the Act.

SOME NCCFFF NEWS

Striperfest 2006 was held on the 4th of November in the Delta at Sugar Barge Marina near Bethel Island. Again it was a huge success. Now in its 10th year, the event raised about \$10,000 for Delta restoration and preservation this year. The weather held and approximately 120 fly fishers had a great day. Evidentially everyone caught fish, with one striper going over 55 inches and weighted in at over 50 lbs. The event is in honor of Dan Blanton. Dan's website is www.danblanton.com. You will find it to be an excellent source for information on the delta and fishing for stripers.

TYING INSTRUCTIONS - CLOUSER MINNOW

Hook: Any standard streamer hook.

Ex. Mustad - 94833 or 3407 plated or 34011 stainless.

Thread: 3/0 brown prewaxed

Bottom Wing: orange buck or calf tail.


Flash: gold or copper krystal flash.

Top Wing: brown buck or calf tail.


Note. I used Brown and Orange color combo for good contrast with white background in Illustrations.

The Clouser Minnow streamer is a fly that should be in every fly fisherman's fly box. The old saying "Don't leave home without it!" applies to this fly like no other. I have caught smallmouth bass, largemouth bass, sunfish, suckers, seatrout, flounder, brook trout, rainbows and browns with this fly. People I know have caught dozens of other species of fresh and saltwater fish using the Clouser Minnow. I know, it really is a lead head jig and technically is not a proper fly at all, but even you dry fly purist should have one tucked away in your vest where your buddies can't see it. It has saved many a slow day and produced the biggest fish of the day. The Clouser Minnow is tied in many color schemes and some with painted or chrome plated lead eyes.


1. Tie in Lead Eyes




2. Tie in Bottom Wing
