Although not in April, the Calaveras Fly



April 25th 7 pm to 9 pm Upcoming outings include Beardsley Afterbay and the onefly contest at White Pines. Come and tie a fly that may or may not work in either or both of those places.... It is fishing after all! \$5 gets you instruction and materials to tie 3 flies. All equipment and materials provided.

The Fly of the Month sessions take place at Oak Grove Park on the fourth Wednesday of the month. Start time is 6:30. Loaner tools are available for those just learning.

April 28th outing to Beardsley Afterbay should provide a good start to the Sierra Trout Season.

ferred method so intermediate, type II, sink tips lines are perfect. Small leaches, damsels, woolly buggers, matukas, pt nymphs, hares ears, prince nymphs, can produce a strike!

PFD, hat, sunscreen, drinking water, sack lunch.

Weather permitting the gate access off hwy 108 on Beardsley Rd. For more information leading up to outing contact summit ranger station.

If the road is open there could be some great fishing on the afterbay.

Join Fishmiester Bill Becket fishing the delta for stripers and large mouth bass on April 29th at Village West Marina.

The closeness of the delta belies its ability to produce some fantastic largemouth fishing. Fishmiester Bill Beckett will lead fellow DFFers in pursuit of this fish and an occasional striped bass at Village West marina at the end of Benjamin Holt Drive. Six and

seven weight rods with sinking lines and bass and striper streamers are the appropriate gear for this fish since topwater action usually doesn't start until late May or early June.

Pontoon boats, prams, kayaks and full sized boats all work as casting

platforms. The marina has a launch ramp should you need one. Fishing starts at 7am with a lunch break planned at about 1pm. Since the marina has two restaurants, including Bob's Giant Burgers, plan to have lunch with the group to finish off the day.

It's almost that time. The Calaveras Challenge One Fly Contest will take place at White Pine Lake, Arnold, May 5th

Do you enjoy friendly competition or what to learn the basics of still-water trout fishing from watching experts? Come out to the annual One Fly Contest hosted by our neighboring club the Calaveras Fly Fishers at White Pine Lake near Arnold (see map) on the first Saturday morning in May. Delta Fly

Fishers members have regularly attended this annual competition and have often won the two awards for most trout and the biggest fish landed using a single fly. For DFF members who have participated in the past, the details of the event and competition is exactly the same as previous years

and without the 2017 hassles of dealing with flood damage to the lake access road.

White Pine Lake is a small lake with a no power boat ban, free public access, and has well maintained park facilities operated by

local volunteers. Typically, the lake is stocked with hatchery trout by the CDFW before the event. But the lake has a healthy population of wild trout and good numbers of bass and sunfish.

This event is a lot of fun and well attended by DFF members of various skill levels. The contest registration starts at 7 am but all competitors must wait until 9 am to start fishing. Usually most DFF participants drive up that morning, enjoy set up their crafts and tackle, partake the coffee and donuts provided by SFF, and smack-talk with the other members. We will also try to arrange an optional breakfast in Arnold for those members who are interested.

Anglers must pair up and verify each other catches. If you lose your fly during the contest, you can continue your fishing but any additional fish do not count toward the contest. The \$25 contestant fee includes a great lunch serving BBQ tri-tip sandwiches, side dishes, soft drinks, and dessert. Funds from the event go to a local education fund. Spectators can also join the lunch for a lesser fee.


Float tube or personal watercraft is necessary to be competitive in the contest. A basic trout rod (9 or 9.5 foot, 4-6 wt) with an intermediate or slow full sinking line (Type I or II) for subsurface nymph or streamer patterns are the most commonly used set up with 7.5 or 9 foot 4x leaders. Small wooly buggers, damsel fly nymphs, red riders, or sheep creek specials are some of the popular choices. Per-

sonal floatation devices are a must. No fishfinders are allowed during the contest. The club members must have signed liability waver on file with our Secretary.

The best fishing for beginners occur if there has been a heavy trout planting before the contest. Under those conditions, high catch rates are the rule. But if not, the more experienced stillwater fishers have a marked advantage. This lake contains a good population of wild and hold-over trout. Every spring, carpenter ant falls and Callibaetis

ing in early spring. Beginning fly fishers can learn a lot about lake fly fishing by just watching the expert fishers and this event is one of the best ways to get to know the other members of the

A Sad Day For Scientific Integrity In The Delta

Nothing grows faster than a fish from when it bites until it gets away.

Over the years many of us concerned about the environment and fisheries of the Delta have respected Dr. Peter Moyle of the Center of Watershed Science, University of California Davis. He has authored a large amount of respected scientific literature. Unfortunately, a recently published white paper has cast doubt on his scientific integrity. Dr. Moyles, along with John Durand and Carson Jeffres, have jointly authored a white paper for the Orange County Coastkeeper (OCC) The paper is titled, "Making the Delta a Better Place for Native Fishes." These recommendations of the white paper will not make the Delta a better place for the native fish but

make the Delta's environment increasingly uninhabitable for those species and increases the probability of their extinction.

What is the Orange County Coastkeeper and why did they commission this white paper? They are strong advocates of Gov. Brown's WaterFix project.

Their financial support comes from the Metropolitan Water District of Southern California (MWD), Southern California Edison (SCE), southern water districts, and companies such as the Irvine Company, Wells Fargo Foundation and the Walmart Foundation. All these groups are supporters of the WaterFix and do not support the Delta, it's environment or it's economy. They also will enjoy a large financial gain if the project is built. The loss of the Delta will be to their financial

benefit.

Garry Brown is the founder and president of the OCC. In his introductory remarks on the white paper, he destroys any scientific credibility Moyle's paper has with his comments that tunnel backers formed a steering committed to provide "guidance" for the white paper. They reviewed the report and made what they considered "appropriate" comments. Evidently Moyle allowed his paper to be revised 7 times until it met OCC's requirements. So much for Moyle's, and his co-authors, scientific integrity.

The white paper is seriously flawed. Some of the it's notable problems are:

. The paper assumed that entrainment of native and introduced fish

will be avoided since the intakes will be near Cortland and above present intakes. Water Fix advocates refer to a new tunnel design that prevents entrainment. The current 60 plus year old fish screens have resulted in millions of lost fish. The "guaranteed" screens they promised would solve the entrainment problem are non-existent, and the design for a new screen is untested and unproven.

.They claim the North-South Delta water flow can be changed to an East-West flow to be more of a naturally occurring flow. Anyone who knows the history of water diversion from the Delta to the south knows this will not happen. There will be major changes in providing investments in habitat restoration for the Delta's fish. It has not happened in the past and there is nothing definitely planned for the future.

Bill Jennings, Executive Director of the California Sportfishing Protection Alliance (CSPA), commented that the paper "Is an embarrassment to Moyle and his reputation." Restore the Delta's Excutative Director, Barbara Barrigan-Parilla joined Jennings' criticism of the paper saying, "I believe Dr. Moyle's delivered a theory based on the opinions of the people who funded his work." She also commented that he will" end up on the wrong side of history."

Jennings based his criticism of Moyle's paper on premises that Moyle cannot be supported by realities facing the Delta. The first criticism is that Moyle's three mile long fish screens will work, even though there is no evidence to support that they will work and they are non-existent. Next, there is no evidence that the proposed habitat restoration will work. Third, Moyle assumes water diversion to the south will not increase. This claim has no basis in reality. And last, that the proposed "adaptive management" will work despite the fact than in over 30 years of using this type of management it has been a failure. Jennings also faulted Moyles when Moyles claimed "meaningful restoration is politically unfeasible." A scientist should never base decisions of science on politics.

Environment and water groups in the San Francisco Bay Area have labeled Moyle's paper for what it is in reality. It's just another of the continuing attempts of southern California organizations at a water grab.

Even the UC Davis authors admitted, "There are huge uncertainties associated with the WaterFix in terms of effects on fish." The Delta Fly Fishers will find Moyle's suggestions for the Delta's fish totally unexceptional. He claims the only thing "politically feasible" for the Delta's fish is to preserve a small number of fish in the North Delta, and turn the East, West, Central and South Delta into a "sacrifice zone" with the loss of the fish populations. It is egregiously repugnant that a scientist of Moyle's reputation would allow himself to use political expediency in his thought process rather than the best scientifically available information. It is sad, for those of us who have held Dr. Moyle in high esteem, see his scientific integrity and credibility greatly diminished.

Transparency Difficult To Find With California's WaterFix

A recent article by Restore the Delta (RTD) disclosed obtaining documents from Metropolitan Water District of Southern California (MWD) and the State Water Contractors (SWC) via the Public Records Act. With the change from a twin tunnel project to a single, phased-in tunnel project the MWD and SWC need data to verify the economic viability of the project. Dr. David Sunding, an economist for the Brattle Group, is performing their analysis.

It seems the MWD and the state were working together on modeling a single, phased in tunnel project even before the DWR had presented it's testimony to the State Water Resources Control Board (SWRCB). In early January of this year, Sunding found he was not getting the preconceived desired results in his modeling of 549,000 acre-feet for the SWC. MWD suggested Sunding should use a "donothing" integrated regional plan baseline that estimates water supply shortage numbers. This creates a false baseline. However, Sunding didn't disclose the altered changes in his report. Because of this and other changes of the baseline, the SWC's water yield increased by 21% to 660,000 acrefeet! On the last day of January, the MWD told Sunding that the Fall Middle River environmental restrictions should be lifted with the assumption the "adaptive management" of the Delta will be successful. By doing so, Sunding's analysis falsely shows the single, phased-in tunnel scheme is economically viable. Of course, by lifting the Fall Middle River environmental restrictions, water to be used for the Delta's fish will again be diverted.

The documents also show that the MWD is still hoping for "participation project split" be-

tween the State Water Project (SWP) and the Central Valley Project (CVP). MWD wants the CVP users to buy 17% of the water from the single tunnel project to help in the projects funding. To date, no CVP contractors are committed to the WaterFix project.

Originally, the tunnel concept proposed that the tunnels, or tunnel, would not flow, or flow at reduced levels during dry years, to protect the Delta fish and prevent salt intrusions into our drinking water. However, the current MWD documents confirm they will be counting on the continuing water flows even during dry weather. Once again, MWD is telling us something with the full intention of violating the agreements.

Despite the WaterFix website's positive spin, the project is in dis-

array. This is especially true of it's financing. The MWD is now considering low-cost federal infrastructure loans using Water Infrastructure Finance Authority (WIFA) money. Traditionally WIFA loans are for infrastructure, rehabilitation, increasing water quality, and waste water and its' reclamation. WIFA loans can be 200 basis points below market value (2%). The WIFA loans could be used to finance 50-100% of the Waterfix. The MWD is also considering a joint public/private loan. During the last week of March, their Board of Directors discussed the possibility of the MWD assuming the


total debt. Their assumption was that servicing the debt will lead to a number of complex legal issues.

Barbara Barrigin-Parilla expressed MWD's ploys well when she commented, "The degree to which MWD is playing fast and loose with the assumptions, baselines, and planning for the Delta tunnels is astonishing. While we expect a regional water district to put it's own interest first, the terms under which it's planning the Delta's future, with the full support of the Brown Administration, feels almost fraudulent." RTD is correct in saying MWD should not be able to manipulate protestants' access to testimony at the SWB, to use faulty assumptions to gain increased water exports, to negotiate loan conditions from the Trump Administration, or to push a project that is only 10% planed and

mits. Barrigan-Parilla and the RTD want the MWD to stop "gaming government processes" to force this project on Californians.

The alliance between the DWR and the MWD does not serve California. They both play fast and loose with the truth to further their agendas. The Brown administration is complicit with this relationship. It furthers his agenda. As the WaterFix project drags on and on, public support for the project continues to decline. The MWD is continuing to push it's agenda forward, with the help of the state's DWR, despite the devastation it will cause the Delta. It's time the Brown administration, state agencies, and legislators need do what is best for California rather than continuing to serve special interest organizations.
