We have a profound concern regarding your actions and inactions as a member of Congress, which appear to contravene your Oath of Office and at a minimum, may constitute treasonous behavior. Despite your sworn duty to uphold the U.S. Constitution and serve the best interests of the American people, your actions have perpetuated harm and injustice at home and abroad.

The violations of your Oath may or may partially include the following:

1. **Government Response to COVID-19 and Lack of Accountability:** You are complicit in allowing the Department of Defense and pharmaceutical companies to develop and distribute experimental COVID-19 "vaccines" without sufficient oversight or accountability, despite ample evidence of their harmful effects. These shots have been linked to a myriad of adverse reactions, including severe allergic reactions, myocarditis, neurological disorders, and death. Moreover, your support for draconian lockdowns, business closures, forced masking, testing, and stay-at-home orders has inflicted untold harm on humanity. These measures have led to widespread job losses, business closures, interruptions in school learning, and mental health crises, with devastating consequences for individuals and families across the country.
2. **Southern Border Crisis:** Your failure to address the ongoing invasion at our southern border, which has facilitated drug, human, child, and sex trafficking, endangering the lives of countless individuals, including innocent children. The porous border has become a gateway for criminal elements, posing a grave threat to national security and public safety.
3. **Proxy Wars:** Your support for proxy wars around the world, including the conflict in Ukraine, which has resulted in the deaths of hundreds of thousands and destabilized entire regions. The toll of human suffering and loss of life in these conflicts is unconscionable and demands immediate attention and accountability.
4. **Palestinian Crisis and Influence of Pro-Israel Lobbyists:** The systematic oppression and violence inflicted upon the Palestinian people, funded in part by American taxpayer dollars, underscores the power of "pro-Israel" lobbyists and the influence they wield over U.S. foreign policy, government, and institutions. While organizations like AIPAC continue to exert significant influence, it is imperative that Congress uphold the principles of democracy and justice by holding accountable those who perpetuate human rights abuses and violations of international law against the Palestinian population.
5. **Lack of accountability for Senior Military Officers:** Additionally, the lack of accountability for senior uniformed military officers who have violated their Oath to the U.S. Constitution is deeply troubling. Despite egregious breaches of military conduct and ethics, many of these officers have faced minimal or no consequences for

their actions, sending a dangerous message of impunity and undermining the integrity of the military institution.

It is evident that Congress has been in possession of ample evidence regarding these claims for years yet has chosen to turn a blind eye and do nothing. Your continued silence and inaction in the face of such egregious violations of human rights, the rule of law, and military ethics is unacceptable.

We demand that you immediately cease and desist from further participation in these treasonous activities and take urgent action to rectify the harm caused by your actions and inactions.
