DERELICTION OF DUTY**

September 2023, the office of KIMBERLY A. HANSON (you), Deputy Director, Congressional Affairs, U.S. Army Material Command, acknowledged receipt of the "NOTICE - Criminal Complaint UCMJ Violations" that GENERAL CHARLES HAMILTON received on 28 November 2023 of the accused: MG ROBERT EDMONSON by the complainant: Mark Charles Bashaw. On 14 December 2023 you provided the following statement to J.M. Phelps:

"Army Materiel Command is aware of Mr. Bashaw's allegation. As a matter of policy, we do not discuss ongoing personnel matters. We do take all allegations seriously and will review the complaint." - KIMBERLY HANSON, Deputy Director, Public & Congressional Affairs, Army Material Command

More than 30 days has lapsed since the original notice was received and no actions have been taken by GENERAL CHARLES HAMILTON, nor has an update given to the Public since 14 December 2023.

This is NOTICE of your failure to conduct your duties of updating the American People, regarding the official "Criminal Complaint UCMJ Violations" that GENERAL CHARLES HAMILTON received on 28 November 2023 of the accused: MG ROBERT EDMONSON by the complainant: Mark Charles Bashaw.

Properly perform your sworn duties (SF61) with a detailed update of the actions being taken, regarding the official Complaint filed with and received by GEN Hamilton. Please send this detailed update to Mr. Phelps and me. Failure to conduct your duties will lead me, through my various media relations, to highlight your dereliction of duties within the Court of Public Opinion.
