

AFFIDAVIT OF TRUTH

Foreign Belligerent Occupation Newburyport, Massachusetts, United States of America April 2024

I am a living soul, a man, created by God, child of God, called by Mother and Father since born Mark-Charles; family of Bashaw (Mark Charles Bashaw). My home of record is Texas, I was raised in Old Town Newbury, Massachusetts, and born in Newburyport, Massachusetts. I lived in Old Town Newbury until I departed for active-duty military service on 17 January 2006. I am one of the People of the 50 states.

United States Constitution Article 4 Section 4: Section 4. "The United States shall guarantee to every State in the Union a Republican Form of Government and shall protect each of them against invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence."

Massachusetts Constitution, Article V. "All power residing originally in the people, and being derived from them, the several magistrates and officers of government, vested with authority, whether legislative, executive, or judicial, are their substitutes and agents, and are at all times accountable to them."

STATEMENT OF FACTS

 On 21 March 2024, it was brought to my attention that the Mayor of Newburyport, Massachusetts intended and scheduled to display a foreign "trans flag" at City Hall, located at 60 Pleasant Street, Newburyport, Massachusetts, 01950, United States, on 30 March 2024.

2. Later in the afternoon on 21 March 2024, I sent a records request via electronic submission (e-mail) to both Senior Lieutenant Richard J. Siemasko of the Newburyport Police Department and Richard B. Jones, Newburyport City Clerk.¹ The records request was for the documented Oaths of Office (Social Contract) for both Mayor Sean Reardon and City Marshal Mark Murray's.

3. On 22 March 2024, Senior Lieutenant Richard J. Siemasko sent me a duly signed Oath of Office contract for City Marshall Mark Murray. It was signed by both Officer Murray and Richard Jones, City Clerk.²

4. On 23 March 2024, I sent Mayor Sean Reardon of Newburyport, Massachusetts a NOTICE of CEASE and DESIST for his scheduled "trans" flag display on publicly owned property, City Hall, Newburyport, Massachusetts. This unlawful and belligerent flag raising was scheduled for 30 March 2024. The Mayor of Newburyport was also served with cease-and-desist notices by Brandon Hayes and Lieutenant William Moseley.

5. On 25 March 2024, Mayor Sean Reardon was lawfully served with certified receipt of all three Cease and Desist Notices from Brandon Hayes, Lieutenant William Moseley, and me (USPS Certified Mail: 9589 0710 5270 0398 0333 28; 9589 0710 5270 1342 4140 40).³

6. On 28 March 2024, Newburyport City Clerk Richard Jones sent me a blank Oath of Office form via email in response to my request for Mayor Sean Readon's duly signed Oath of Office (contract).⁴

7. Later in the afternoon on 28 March 2024, I sent a USPS certified notice (9590 9402 8616 3244 9067 93) to Newburyport City Clerk Richard Jones for a records request for the duly signed Oath's of Office of the following named individuals: Sean Reardon (Mayor), Richard Jones (City Clerk), Heather L. Shand, (Councilor At-Large), Edward C. Cameron Jr. (City Council President Councilor), Andrew Levine (Chief Administrative Officer).⁵

8. On 30 March 2024, Mayor Sean Reardon raised the unlawful and foreign "trans flag" on publicly owned property, violating lawfully served cease and desist notices from the People, and claiming and certifying his allegiance to a foreign enemy of the United States of America, the Commonwealth of Massachusetts, and the City of Newburyport.⁶

9. On 02 April 2024, City Clerk Richard Jones was in receipt of Records Request for the Oaths of Office of the individuals listed above, including Mayor Reardon. He was given 21 days to produce these records.

10. As of 24 April 2024, Richard B. Jones was unable to provide and satisfy the formal records request for the duly signed Oaths of Office (contracts). No such records exist lawfully and certifiably in the public records. Without these duly signed lawful social contracts (Oaths of Office), the named individuals above do not possess lawful authority and are foreign to the Supreme Laws of the Land (United States Constitution & Massachusetts Constitution).

11. The individuals named in paragraph seven are not lawful magistrates or officers of government. They are foreign entities and do not adhere to the most fundamental laws—the laws of nature; instead, they publicly support defilement, mutilation, subversion, mental enslavement, and castration of men, women, children, and the laws (domestic violence). They are engaged in a foreign belligerent occupation, disguising themselves as lawful public servants, and actively aiding and abetting a foreign enemy in the subversion of the United States of America, the Commonwealth of Massachusetts, and Newburyport (Republics).

12. Sean Reardon is contracted with ActBlue, an alleged foreign donor honey pot disguised as a legitimate donations platform, during and for his campaign for Mayor of Newburyport, Massachusetts.⁷ <u>https://secure.actblue.com/donate/seanreardon4mayor-website</u> is still live as of 24 April 2024. ActBlue's headquarters are in Somerville, Massachusetts.

13. "I, Mark Charles Bashaw, having been appointed an officer in the Army of the United States, as indicated above in the grade of OE-2 (First Lieutenant) do solemnly swear (or affirm) that I will support and defend the Constitution for the United States (Republic) against all enemies, foreign and domestic, that I will bear true faith and allegiance to the same; that I take this obligation freely, without any mental reservation or purpose of evasion; and that I will well and faithfully discharge the duties of the office upon which I am about to enter; SO HELP ME GOD."⁸



Dear Mr. Reardon,

It has come to my attention that you are intending to display a "trans flag" at City Hall, located at 60 Pleasant Street, Newburyport, Massachusetts, 01950, United States, on March 31st, 2024. I wish to bring to your attention that such a display in an attack on the supreme law of our land, which is founded upon the laws of nature and nature's God.

As a child of God, proud American and one of the People, I, Mark Charles Bashaw, hold a deep reverence for our community's values, traditions, and laws. With over 18 years of honorable service in the military, including 10 years spent overseas, I am committed to ensuring our form of government is maintained (Constitutional Republic). It is also my responsibility as one of the people.

Moreover, it is worth noting that I have a profound connection to Newburyport, Massachusetts, where I was born and raised.

According to the supreme law of our land, which encompasses the principles of natural law and common law, the will of the people is paramount. 





Dear Ms. Wallace-Jones:

As Chairman of the U.S. House of Representatives Committee on House Administration, which has broad jurisdiction over federal campaign finance law,¹ I write today to request information on ActBlue's donor verification policies and procedures. At our recent full committee hearing concerning the oversight of the Federal Election Commission,² committee members and some commissioners expressed concern over lenient donor verification standards.

Further, the Committee is aware of allegations from across the country that malicious actors have used ActBlue's systems to funnel unlawful funds to political committees on your platform in federal elections,³ as well as in state elections, such as the recent judicial election for Wisconsin Supreme Court.⁴ In some cases, reports allege that such persons are using untraceable, prepaid cards to "wash" otherwise impermissible funds into apparently clean contributions, possibly including money from foreign sources.⁵ Federal law prohibits contributions from foreign nationals to federal, state, or local campaigns.⁶ Allegations also suggest that malicious actors employ standard identity theft practices to send unlawful funds through ActBlue platform users, with the names of actual persons used to make contributions without their knowledge or consent.⁷

In response to this letter, please provide answers to the following:

- 1) Federal law imposes many restrictions on political committees, including those that ultimately receive contributions through conduit platforms like ActBlue. Those committees are responsible for ensuring any contributions they accept comply with law. Even though these responsibilities are not imposed on ActBlue, does ActBlue nevertheless take any voluntary steps to ensure that only real persons are able to make contributions to political committees that use ActBlue's platform?
- 2) Specifically, has ActBlue chosen to require the provision of a credit card security code or other identifying information as a condition of using its platform to make a contribution to a political committee?
 - i) If not, why not?
- 3) If federal law were amended to require additional verification to confirm the identity of potential contributors, such as the provision of a credit card security code for relevant transactions,⁸ what would the resulting effect be on ActBlue?
- 4) Should the committee explore other areas as it examines the issue of preventing foreign money from being used in American elections?
- 5) Could many of these alleged schemes have been prevented had ActBlue employed standard online financial security practices?
