\$11,835.25 Aesthetic Improvements to Founding Fathers Park

\$18,852.07 Commercial Street Beautification (includes 6 Waste Receptacles and 4 Benches)

\$632.50 Signage for Lockhart-Ryan Park

S39,604.25 Total
