Budget 2022-2023

The Operations Manager presented the Capital Budget for 2022-2023. The budget was reviewed in detail. Elements of the budget include the following:

- Aalders Avenue Water Laterals-Phase #1
- RF Meter Reading System Meters
- Test Well
- UV Protection System
- Submersible Pump
- Water Meter Purchases
- Tank Refurbishment Inspection
- Total Expense: \$402,200.00 with \$401,000 eligible for Gas Tax.

The Capital Budget was reviewed in detail and the Commission requested that the Operations Manager speak with other surrounding Towns, Villages or Municipalities about their UV Protection System and questions whether it is a necessary measure. The Operations Manager will look into this and bring it to the next meeting of the Water Commission.

THAT the Capital Budget for 2022-2023 be accepted, as presented with the UV Protection System omitted for the time being.

Financial Update

The Water Commission reviewed the year to date Income Statement for the New Minas Water Commission, as of March 23:

$799,605 in Revenues (versus $799,224 last period) $910,115 in Expenses (versus $899,570 last period) ($110,510) Net (versus ($100,346) last period)

The year to date deficit is due mainly to the transfer of Water Commission funds to the Village of New Minas at the commencement of the fiscal year for staffing and services provided by the Village:

$5,000 in Snow Clearing Services
$3,088 in Lease & Services Agreements
$3,000 in Postage & Office Supplies
$15,073 in Insurance

\$5,500 in LMCC Contribution \$309,060 in Depreciation \$573,925 Total

One quarter of water revenue is yet to be invoiced.
