## **Business Arising from Minutes:**

#### Presentation:

Jessica Gilice from the Nova Scotia Invasive Species Council provided a presentation to the Committee on their work in the province. Specifically, the presentation focused on the presence of the Yellow Iris and its harmful effects on the ecosystem.

#### **Budget Update:**

The Clerk Treasurer/CAO provided the following budget update:

- \$3140.01 in expenses incurred to date as part of Trash/Recycling Receptacles
- \$115.37 in expenses incurred to date as part of Trash/Recycling Receptacles
- \$312.86 in expenses incurred to date as part of Plant Installation @ Founders Park
- \$1045.00 in expenses incurred to date as part of Plant Installation @ Founders Park
- \$573.57 in expenses incurred to date as part of Crescent Park West
- \$354.46 in expenses incurred to date as part of Crescent Park West
- \$938.57 in expenses incurred to date as part of Crescent Park West
- \$354.46 in expenses incurred to date as part of Crescent Park West
- \$6834.50 expensed, year to date

The Clerk Treasurer/CAO advised that the Committee has incurred \$2221 in expenses related to the placement of plants at Crescent Park West instead of at the Roundabout. The former project is an unbudgeted capital project. The recommendation was made that the Committee should seek approval from Village Commission on re-allocation of this capital funding. Otherwise, the expenses will need to be incurred in the Operating Budget.

THAT the Village Commission be requested to re-allocate the capital funding for the Irrigation System (\$4000) to the Crescent Park West Project.

THAT the Village Commission be requested to re-allocate the capital funding designated for Solar Holiday Lights for Power Poles & Roundabout (\$5000) to LED Lights for Area Parks and Roundabout.

#### **New Business:**

Planning Process for Long Term Capital Plan

The Committee members were again encouraged to add ideas to the Planning Document, which could be shared, discussed, and rationalized at a future meeting. The immediate priority will be to determine capital objectives for the 2022-2023 fiscal year. In addition, the Chair advised the Committee that the Commission is contemplating a strategic plan process.

#### Tulip Donation

The Sunrise Rotary Club is prepared to make a donation of 8-13 dozen tulips for placement in the Village. The Committee was thankful for the donation and determined that Founders Park would be the best location for placement, with Crescent Park West being a secondary location for any leftover plants.

## Request from Blomidon Naturalist Society

John Ansara advised that a request has been received from the Blomidon Naturalist Society for placement of a pollinator garden in the Village for the purposes of butterfly enhancement. The Committee directed John to ask the Society to make a presentation at an upcoming meeting of the Committee.

#### **Next Meeting Date:**

The Committee discussed whether the meetings should remain online and via videoconferencing, which is now permitted under the Meetings & Procedures By-law, which was adopted by the Commission at the October 12 meeting.

THAT the Beautification Committee recommends to Village Commission that its committee meetings be held via videoconference, in accordance with Section 8 of the Meetings & Procedures By-law.
