#### **Presentations:**

**Operating Budget** 

The Clerk Treasurer/CAO and the Operations Manager presented the Operating Budget for 2021-2022. The budget was reviewed in detail. Elements of the budget include the following:

- \$934,318 in Revenues
- \$934,318 in Expenses
- No changes in rates
- \$15,000 in Engineering Expenses allocated, which includes a Water Rate Study
- \$300,060 in Depreciation Expense is single largest expense
- \$213,885 in Wages & Benefits comprises the second largest expense

The last Water Rate Study was conducted in 2007. Therefore, the need for an updated study was identified. The Commission recommended an updated account name for Account #W25500. Therefore, the account will be designated as "Regulatory Expenses". The Clerk Treasurer/CAO commented that Section 11 of *An Act to Incorporate the New Minas Water Commission*, establishes the remuneration for Commissioners and, therefore, the amounts cannot be altered without a change in legislation. The Clerk Treasurer/CAO committed to researching this further.

THAT the Operating Budget for 2021-2022 be accepted, with the aforementioned notation.

Source Water Protection Committee Terms of Reference
