Financial Update

The Clerk Treasurer/CAO presented the Income Statement for 2021-2022 for the New Minas Water Commission as of June 22. This is the first such presentation of the fiscal year.

\$251,970 in Revenues \$615,738 in Expenses (\$363,768) Net

The deficit is due mainly to the transfer of Water Commission funds to the Village of New Minas at the commencement of the fiscal year. Approximately \$547,388 of the expenses are annual payments to the Village for the following services for the year:

Reports:

Water Operations Report

Gerard Hamilton presented the Water Operations Department Report. In addition to his report, Mr. Hamilton also presented a letter received from Randy Hayward, Rexel Canada Electrical Inc. In his correspondence, Mr. Hayward opined that the most likely cause of the failure in functionality of two 40 HP 575Vac Vacon Variable Speed Drives at Cornwallis Wells #3 and #4 was due to continuous cycling of the input power off and on. The lends support to Mr. Hamilton's opinion that the failure occurred with the change of the power meter by Nova Scotia Power at that location, since the failure occurred at the same time as the meter change. On behalf of the Commission, Mr. Hamilton will continue to pursue remediation from Nova Scotia Power.

New Business:

New Minas Water Commission Act - Draft

The Clerk Treasurer/CAO presented, for discussion purposes, a draft of the New Minas Water Commission Act. The aforementioned document is designed to commence the process to renew and update the existing legislation, *An Act to Incorporate the New Minas Water Commission*, which was adopted in 1982. The draft has been reviewed by the Municipal Advisor and legal counsel and their comments have been incorporated. The document is similar to the existing *Act*, but proposes several changes for consideration:

- Updates the language and modernizes the terminology in the Act
- Proposes "natural persons" powers in Section 15
- Addresses the matter of honorarium amounts for Commissioners that was contained in the former Section 11 by rewording Section 11
- Repeals the former Act in Section 22

Mr. Chaulk enquired about the proposition of "natural persons" powers. The Clerk Treasurer/CAO advised that it may be desirable to propose such. Since the legislation would be intended to govern the affairs of the Commission for some time into the future, the provision may provide flexibility for the Commission to respond to events or circumstances which cannot yet be contemplated.

THAT the document New Minas Water Commission Act be endorsed as presented, and, furthermore, that the Clerk Treasurer/CAO be directed to send the document, with a copy of this Motion, to the Member of the Legislative Assembly for Kings South for review and consideration of the Legislative Assembly of the Province of Nova Scotia.
