## AMENDMENT TO THE DECLARATIONS OF COVENANTS AND RESTRICTIONS FOR WATERFORD VILLAS

THIS AMENDMENT TO THE DECLARATIONS OF COVENANTS AND RESTRICTIONS FOR WATERFORD VILLAS (hereafter "Amendment") is made to The Declarations Of Covenants And Restrictions For Waterford Villas file in Book 2174 Page 23 of the St. Charles Recorder of Deeds on December 14<sup>th</sup>, 1998, as Amended (hereafter "Covenants") and entered into as of property of November, 2015, by the Owners of The Waterford Villas Homeowners Association (hereafter "Owners").

## WITNESSETH:

WHEREAS, the original Declaration of Covenants and Restrictions for Waterford Villas was filed at Book 2174 Page 23 through Page 46 of the records of the Recorder of Deeds of St. Charles County on or about December 14, 1998; and

WHEREAS, The first Amendment to the original Declarations was filed at Book 2564, Page 245 through Page 246 of the records of the Recorder of Deeds of St. Charles County on or about April 25, 2001; and

WHEREAS, The second Amendment to the original Declarations was filed at Book DE4369, Page 453 through Page 486 of the records of the Recorder of Deeds of St. Charles County on or about December 12,2005;and

WHEREAS, the third Amendment to the original Declarations was Book DE4886, Page 707 of the records of the Recorder of Deeds of St. Charles County on or about December 03, 2007;and

WHEREAS, Article XIV Section 4 of the Covenants allows for Amendment of the Covenants by 2/3 of all Owners; and

WHEREAS, the requisite number of Owners voted to approve this Amendment and agree to be bound by the Amendment; and

WHEREAS, the Board of Directors hereby file the following amendments as required by Article XIV Section 4;

NOW, THEREFORE, be it known as follows:

1. That Article XIV Section 4 shall be amended by striking the following language:

"Until all Lots authorized to be developed in the Property have been sold and conveyed for residential use, the provisions of this Declaration may only be amended, modified or changed by First Party by recording an instrument of amendment in the Page 1 of 3

Office of the Recorder of Deeds for St. Charles County, Missouri. Thereafter, the provisions hereof may only be amended, modified or changed by the written consent of two-thirds (2/3rds) of all the Owners"

And replacing it with the following language:

"the provisions hereof may only be amended, modified or changed by the affirmative vote of not less than two-thirds (2/3) of all valid ballots cast by a quorum representing 50% of the eligible members of the Association,"

2. That Article X Section 3a shall be amended by striking the following language:

"The maximum deductible to be maintained under this insurance, with the exception of earthquake is \$10,000 per occurrence. The Association may choose to maintain a deductible of less than \$10,000."

And replacing it with the following language:

"If the deductible to be maintained under this insurance, with the exception of earthquake, would exceed \$10,000 per occurrence, the deductible level must be approved by the Board of Directors."
