The text of help below handwritten plea for help to city council Conrad, left with no mere visit (July 9, 2025)




This morning I was to participate in online international symposium, in the first of the kind event for occupational hazards in Music. And my expectations were to present my textbook changing discovery, related to Bach's music to colleagues, through networking and sharing my new e-book for collaboration goals for international engagement but... I was prevented from charging devices! due to electric power being deliberately(!) shut down?!

No matter how you look at this, there is no rational and logical explanation to such malice of public safety hazard, especially in the context of the catastrophe that DISABLED SCHOLAR had to deal with, due to the circumstances of outstanding and long lasting hardship. However, aside from my personal struggle, the created by this irrational hostility problem of lacking opportunity to charge phone for emergency uses in this area of remote hiking is THE OBVIOUS PUBLIC HAZARD.

- Notably, due to unknown to me circumstances, in a couple of hours Dannie returned and without any explanation and with no apology he announced that he restored access to electricity back.
- But I still could not join the rest of the online symposium, because of bad reception and the need to walk to the beach after charging the phone finally in late afternoon, since suddenly I've been held hostage by the next team of harassers with the official badges Alex
 Tripolsky and Carrie Rios. And, this time the code enforcement department employees arrived to the location, where I was bound to remain with NO RELEVANT HELP FOR THE OBVIOUSLY NEEDED CAR REPAIR/TOW. (But this administration of city of Malibu is likely one of the most affluent on the planet, yet it is consumed by the dangerous level of fatigue of most fundamental compassion to suffering and their routine practices and policies that reflect such dangerous state of collective consciousness...) 

They knew I was facing a threat of loosing the car, due to caused by mismanaged rodents, but did nothing despite knowing of essential transportation/ shelter it serves for my sustainability, due to severe disability. Their contrary to logic and common sense, ill minded teamwork actions of making hard and impossible to find solutions for fixing the problem even on my own are evident of MISFIT TO PUBLIC SERVANT's fundamental duties. Drew Belter (park maintenance) saw my handwritten warnings re danger of rodents for disabled cars, instead of preventing from reoccurrence of the problem, he stated his senseless excusiology to avoid it, as he took it off(!). And not only he deliberately DID NOTHING TO MITIGATE THE PROBLEM caused by the gross and mindless






